ORDINANCE 46-2024

AN ORDINANCE AMENDING SECTION 115.490 COMPENSATION OF THE MUNICIPAL CODE OF THE CITY OF ELDON, MISSOURI, BY REVISING SECTION 115.490.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF ELDON, MISSOURI, AS FOLLOWS:

- Section 1. That Section 115.490 Compensation, of the Municipal Code of the City of Eldon, Missouri is hereby revised. Deletions have a “strike through” (~~example~~) and additions are in **bold**.
- Section 2. Section 115.490 Compensation shall be substantially the same in form and content as attached hereto as Exhibit A.
- Section 3 This Ordinance shall be in full force and effect from and after its passage and approval.

Section 115.490. Compensation. [Ord. No. 1703 §2, 3-24-1998; Ord. No. 1890 §2, 3-11-2003; Ord. No. 1981 §§1 — 2, 3-8-2005; Ord. No. 2010-08 §§1 — 2, 3-23-2010]

- A. The Board of Aldermen does hereby fix the compensation of the following enumerated officers of the City of Eldon, Missouri, provided that the salary or compensation of an officer shall not be changed during the term for which he/she is elected or appointed except as specified herein. However, any officer may decline compensation if they desire by notifying the City Clerk in writing.
1. *Aldermen:* Compensation of the Aldermen is set at two hundred dollars (\$200.00) per month and the ability to utilize the gym membership that the City is in contract with at the cost of the City. [Ord. No. 23-2024, 3-26-2024]
 2. *City Attorney:* Compensation of the City Counselor is set at one thousand one hundred dollars (~~\$1,100.00~~) (**\$800**) per month.
 3. *City Prosecutor:* Compensation of the City Prosecutor is set at seven hundred dollars (\$700.00) per month. [Ord. No. 26-2019, 7-23-2019; Ord. No. 42-2019, 11-12-2019]
 4. *City Marshal/Ex Officio Collector:* Compensation of the City Marshal is set at three thousand five hundred eighty-three dollars thirty-four cents (\$3,583.34) per month (forty-three thousand dollars (\$43,000.00) annually).
 5. *Mayor:* Compensation of the Mayor is set at four hundred dollars (\$400.00) per month and the ability to utilize the gym membership that the City is in contract with at the cost of the City. [Ord. No. 2016-05 §§1 – 2, 1-19-2016; Ord. No. 42-2019, 11-12-2019; Ord. No. 23-2024, 3-26-2024]
 6. *Municipal Judge:* Compensation of the Municipal Judge is set at nine hundred eighty-three dollars thirty-three cents (\$983.33) per month.
