

**ORDINANCE 1687-24**

CAPITAL ORDINANCE OF THE BOROUGH OF EMERSON, IN THE COUNTY OF BERGEN, NEW JERSEY, AUTHORIZING THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND ACQUISITIONS IN, BY AND FOR THE BOROUGH, APPROPRIATING THEREFOR THE SUM OF \$236,825 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND.

BE IT ORDAINED by the Borough Council of the Borough of Emerson, in the County of Bergen, New Jersey, as follows:

Section 1. The Borough of Emerson, in the County of Bergen, New Jersey (the "Borough") is hereby authorized to make the following public improvements and acquisitions in, by and for the Borough: (A) undertaking of the Borough Document Scanning Project (Phase I); (B) undertaking of various improvements to parks and recreation facilities; (C) undertaking of various improvements to public buildings and sidewalks; (D) acquisition of e-ticketing equipment, automated license plate reader equipment and radios for the use of the Police Department; (E) upgrading of the Fire Department Radio Room; (F) acquisition of personal protective equipment for the use of the Fire Department; (G) acquisition of radios for the use of the Fire Prevention Bureau; (H) acquisition of a lawn mower for the use of the Department of Public Works; (I) installation of generator power transfer switch at the Firehouse; and (J) acquisition of personal protective equipment for the use of the Volunteer Ambulance Corps. Said improvements and acquisitions

shall include all work, materials and appurtenances necessary and suitable therefor.

Section 2. The sum of \$236,825 is hereby appropriated to the payment of the cost of the improvements and acquisitions authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Borough's Capital Improvement Fund, as hereinafter provided. The sum of \$236,825 is hereby appropriated from the Borough's Capital Improvement Fund to the payment of the cost of said purpose.

Section 3. Said improvements and acquisitions are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvements and acquisitions shall be made as general improvements, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Borough Clerk and is available for public inspection.


Section 5. This ordinance shall take effect at the time and in the manner provided by law.
