## **ORDINANCE NO. 1266**

## AN ORDINANCE OF THE BOROUGH OF EMMAUS, LEHIGH COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15 §210 OF THE EMMAUS BOROUGH CODE, RESTRICTING LEFT TURNS FROM KLINES LANE TO MAIN STREET DURING CERTAIN SCHOOL HOURS

WHEREAS, the Borough Council of the Borough of Emmaus has established, through its Codified Ordinances, that vehicle traffic is regulated and directed at certain locations throughout the Borough; and

WHEREAS, representatives of Seven Generations Charter School have made a request for additional traffic control devices at the intersection of Klines Lane and Main Street; and

WHEREAS, the Emmaus Police Department has conducted a traffic study at the intersection of Klines Lane and Main Street; and

WHEREAS, the Public Safety Committee of Council and the Emmaus Police Department recognize the congestion and dangers of turning traffic during certain hours on school days at this intersection; and

**WHEREAS**, it is the desire of the Council of the Borough of Emmaus to enhance the safety of the intersection.

**NOW, THEREFORE, BE IT HEREBY ORDAINED AND ENACTED,** that Chapter 15 of the Codified Ordinances is amended as follows:

 §210 as established by Ordinance 675 and amended by Ordinance 827 and Ordinance 1099. Right Turns Only Permitted at Certain Intersections. The amendments to this Subsection shall be as follows:

§ 210.1 shall be amended to add the following:

Add	Klines Lane	North	School Days: M – F 8:00 AM – 9:00 AM 3:00 PM – 4:00 PM	Main Street

- 2. <u>REPEALER</u>: All existing Ordinances of the Borough or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed.
- 3. <u>SEVERABILITY</u>: If any section or provision of this Ordinance is declared by any Court of competent jurisdiction to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the constitutionality, legality, or validity of this Ordinance as a whole, nor the constitutionality, legality, or validity of any other section or provision of this Ordinance other than the one so declared to be unconstitutional, illegal, or invalid.
