**ORDINANCE NO. 1270**

**AN ORDINANCE OF THE BOROUGH OF EMMAUS, LEHIGH COUNTY, PENNSYLVANIA, AMENDING  
CHAPTER 15 §602.3.A OF THE EMMAUS BOROUGH CODE, AMENDING THE RESIDENTIAL DISABLED  
PARKING SIGN AND ASSIGN A PERMITTED PARKING SPOT ON THE PUBLIC STREET LOCATED IN FRONT  
OF 224 ADRAIN STREET WITHIN THE BOROUGH OF EMMAUS**

**WHEREAS**, the Borough of Emmaus, Lehigh County, Pennsylvania, is authorized by the Pennsylvania Borough Code to establish parking restrictions on the public streets located within the Borough; and

**WHEREAS**, Chapter 15 §602.3.A of the Emmaus Borough Code establishes Disabled Parking restrictions on public streets within the Borough; and

**WHEREAS**, Emmaus Borough Council previously adopted Ordinance No. 1139, allowing Borough Council to assign permitted parking spaces to the resident at 224 Adrain Street; and

**WHEREAS**, the individual living at the residence located at 224 Adrain Street in the Borough of Emmaus qualifies for a permitted disabled parking space; and

**WHEREAS**, due to certain street restrictions and traffic conditions adjacent to the property, and after discussing the matter with neighbors and conducting certain research, the Emmaus Police Department has recommended approval of a permitted disabled parking space for this individual in front of the property at 224 Adrain Street; and

**WHEREAS**, the resident at 224 Adrain Street has received a new Disabled Parking Placard number, thus requiring the Borough to amend Ordinance No. 1139 to reflect the new placard number and the associated permitted parking space.

**NOW THEREFORE BE IT ORDAINED**, that the Council of the Borough of Emmaus hereby authorizes the installation of assigned permitted parking space at the following location:

1. In the public street located in front of the address located at 224 Adrain Street.
2. The new permit number for the assigned location shall be **I46690P**.

**BE IT FURTHER ORDAINED AND ENACTED** that the officers and employees of the Borough of Emmaus are hereby empowered and directed to erect such signs and street markings as may be necessary to notify the public of this Ordinance, and to issue citations for violations thereof, pursuant to the Codified Ordinances of the Borough and the Motor Vehicle Code.

**BE IT FURTHER ORDAINED** that all existing Ordinances of the Borough or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed.

**BE IT FURTHER ORDAINED**, that if any section or provision of this Ordinance is declared by any Court of competent jurisdiction to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity shall not affect the constitutionality, legality, or validity of this Ordinance as a whole, nor the constitutionality, legality or validity of any other section or provision of this Ordinance other than the one so declared to be unconstitutional, illegal, or invalid.
