## ORDINANCE 2024-09

# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ENCINITAS, CALIFORNIA, AMENDING ENCINITAS MUNICIPAL CODE CHAPTER 2.12 CONFLICT OF INTEREST CODE, SECTION 2.12.060(C) DESIGNATED CITY POSITIONS

WHEREAS, Government Code Section 87306.5 requires every local government agency to review its Conflict of Interest Code by July 1 of each even-numbered year to determine if it is accurate or if the code must be amended. In addition, at any time an agency may amend its code when change is necessitated by changed circumstances, including the creation of new positions and position title changes.

WHEREAS, Staff has reviewed the City's Conflict of Interest Code, including the list of designated employees and disclosure categories, and determined that amendments are necessary to EMC Chapter 2.12 Conflict of Interest Code, Section 2.12.060(C) Designated City Positions.

**NOW, THEREFORE**, the City Council of the City of Encinitas, California, hereby ordains as follows:

### SECTION ONE:

That Encinitas Municipal Code Chapter 2.12 Conflict of Interest Code, Section 2.12.060(C) Designated City Positions is hereby amended as shown in **Exhibit A** to this Ordinance.

### SECTION TWO: ENVIRONMENTAL COMPLIANCE.

The action being considered by the City Council is exempt from the California Environmental Quality Act (CEQA) because it is not a "project" under Section 15378(b)(5) of CEQA Guidelines. The action involves an organizational or administrative activity of government that will not result in the direct or indirect physical change in the environment.

#### SECTION THREE: CONSISTENCY.

Any provision of the Encinitas Municipal Code or appendices thereto inconsistent with the provisions of this Ordinance, to the extent of such inconsistencies and no further, is hereby repealed or modified to that extent necessary to affect the provisions of this Ordinance.

#### **SECTION FOUR:** SEVERABILITY.

If any chapter, article, section, subsection, subdivision, sentence, clause, phrase, word, or portion of this Ordinance, or the application thereof to any person, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portion of this Ordinance or its application to other persons. The City Council hereby declares that it would have adopted this Ordinance and each chapter, article, section, subsection, subdivision, sentence, clause, phrase, word, or portion thereof, irrespective of the fact that any one or more subsections, subdivisions, sentences, clauses, phrases, or portions of the application thereof to any person, be declared invalid or unconstitutional.

# SECTION FIVE: EFFECTIVE DATE.

This Ordinance shall take effect and be in force thirty (30) days after its passage and the City Clerk of the City of Encinitas is hereby authorized to use summary publication procedures pursuant to Government Code Section 36933 utilizing the Coast News, a newspaper of general circulation published in the City of Encinitas.

This Ordinance was introduced at a regular meeting of the City Council held on the 14th day of August 2024.
