**SUBJECT: SALARY ORDINANCE – CLERK OF THE BOARD OF COUNTY COMMISSIONERS**

**WHEREAS**, pursuant to N.J.S.A. 40:41A-38 and 41(b), the salary for the Clerk of the Board of County Commissioners shall be set by Ordinance; and

**WHEREAS**, the last salary range adjustment for this position was approved by Ordinance O-2014-00002. Salary ranges for comparable positions throughout the County of Essex have been adjusted in both 2020 and 2022; and

**WHEREAS**, the purpose of this requested Salary Ordinance is to adjust the salary range for the Clerk of the Board to make it commensurate with comparable positions throughout the County; and

**WHEREAS**, the Essex County Board of County Commissioners hereby establishes the salary range and effective date set forth herein; Now, therefore be it

**ORDAINED**, by the Essex County Board of County Commissioners:

1. The salary range for the Clerk of the Board of County Commissioners shall be \$96,850-\$139,000, effective July 1, 2024.
2. A public hearing shall be held on this Ordinance shall be held on August 14, 2024, at 5 pm at Montclair Town Hall, 205 Claremont Avenue, Montclair, NJ.
3. The Clerk of the Board of Commissioners is hereby directed to publish and distribute this Ordinance in accordance with applicable Provisions of Law.
4. That this Ordinance shall take effect at the time and in the manner prescribed by law.
