## TOWNSHIP OF EVESHAM ORDINANCE NO. 3-2-2024

# ORDINANCE OF THE TOWNSHIP OF EVESHAM AMENDING CHAPTER 150-50 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF EVESHAM

ENTITLED: "VEHICLES AND TRAFFIC"

TO DESIGNATE A SECTION OF HOPEWELL ROAD AT ABERDEEN COURT AS A "NO PASSING ZONE"

WHEREAS, pursuant to N.J.S.A. 39:4-197, the Township Council of the Township of Evesham has the authority to designate "no passing" zones where overtaking and passing or driving to the left of the roadway is deemed especially hazardous on those streets under the Township's jurisdiction; and

WHEREAS, it has been reported that the Arbor Walk residential development area at the Aberdeen court intersection was constructed without modification to the passing lanes. Vehicles conducting a passing maneuver are permitted to do so across the Aberdeen court intersection, and may not see vehicles attempting to turn out of the development onto Hopewell Road, which now presents a passing sight distance hazard; and

WHEREAS, the Township Council, in the interest of safety, has determined to designate a section of Hopewell Road at the intersection of Aberdeen Court as a "no passing" zone.

NOW THEREFORE BE IT ORDAINED by the Council of the Township of Evesham, in the County of Burlington and State of New Jersey that the Township Code be amended as follows:

SECTION ONE: \$150-50. Schedule XIX: No-Passing Zones is hereby amended to include the following:

Name of Street

Hopewell Road (southbound travel lane and northbound travel lane, starting from the intersection of Aberdeen Court to a point approximately 700 feet south and 700 feet north)

#### SECTION TWO. REPEALER

All Ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

#### SECTION THREE. INVALIDITY

If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or

provision and the remainder of this ordinance shall be deemed valid and effective.

### SECTION FOUR.EFFECTIVE DATE

This ordinance shall take effect immediately upon final passage and publication according to law.

#### SECTION FIVE:

A certified copy of this ordinance shall be transmitted to the Commissioner of Transportation within thirty (30) days of its adoption.
