

**TOWNSHIP OF EVESHAM
ORDINANCE NO. 5-4-2024**

**AN ORDINANCE AMENDING SCHEDULE VIII (§ 150-39) IN ACCORDANCE WITH
§ 150-15 OF THE CODE OF THE TOWNSHIP OF EVESHAM TO INCLUDE NEWLY
DESIGNATED STOP SIGN INTERSECTIONS**

Whereas, the Township of Evesham (“Township”) will designate and install stop signs at four intersections in the Barton Run community; and

Whereas, § 150-15 of the Code of the Township of Evesham, entitled “Stop intersections designated”, governs the intersections designated as stop intersections requiring stop signs; and

Whereas, § 150-15 of the Code of the Township of Evesham provides that all stop intersections in the Township must be listed in Schedule VIII, § 150-39, entitled “Stop Intersections”; and

Whereas, Remington & Vernick Engineers performed an inspection of the intersections in the Barton Run community and determined four intersections which meet the requirements for the placement of stop signs; and

Whereas, the addition of the stop signs will improve the general health and welfare of the Township by creating safer roadways; and

Whereas, the Township determined Schedule VIII, § 150-39, must be amended to include the newly designated stop intersections.

NOW, THEREFORE BE IT RESOLVED, by the Evesham Township Council of the Township of Evesham, in the County of Burlington, New Jersey, that Schedule VIII, otherwise referred to as § 150-39, entitled “Stop Intersections”. is amended to additionally include as follows:

Intersection	Stop Sign On
Lakeside Drive and Foxwood Lane	Foxwood Lane
Lakeside Drive and Lakeside Drive	Lakeside Drive
Foxwood Lane and Shady Lane	Shady Lane
Shady Lane and Foxwood Lane	Foxwood Lane

SECTION II. REPEALER

All Ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION III. INVALIDITY

If any section, paragraph, subdivision, clause or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this ordinance shall be deemed valid and effective.

SECTION IV. EFFECTIVE DATE


This Ordinance shall take effect 20 days after its proper publication after final passage as required by law.


