**A RESOLUTION AUTHORIZING THE PERSON-TO-PERSON TRANSFER OF BDS ENTERPRISES, INC. (IN POCKET LICENSE NO. 1102-33-008-004); A PLENARY RETAIL CONSUMPTION LICENSE TO ROBERT GELBARD**

**Resolution #23R-** WHEREAS an application was filed on January 6, 2023 for the person-to-person transfer of Ewing Township Plenary Retail Consumption Liquor License for BDS Enterprises, Inc. (in pocket License No. 1102-33-0008-004), to Robert Gelbard of Skillman, New Jersey 08558; and

WHEREAS, the submitted application form is complete in all respects, the transfer fees have been paid, and the license has been properly renewed for the current license term; and

WHEREAS, the applicant is qualified to be licensed according to all standards established by Title 33 of the New Jersey Statutes, regulations promulgated there under, as well as pertinent local ordinances and conditions consistent with Title 33; and

WHEREAS the applicant has disclosed and the Ewing Township Police Department as the issuing authority has reviewed the source of all funds used in the purchase of the license and the licensed business and all additional financing obtained in connection with the licensed business; and

WHEREAS, upon this submission, dated May 23, 2023, no objection(s) has/have been received by the Clerk of the Township of Ewing to the re-issuance of said license; and

NOW, THEREFORE, BE IT RESOLVED that the Ewing Township Municipal Council does hereby approve, effective May 23, 2023, the transfer of the aforesaid Plenary Retail Consumption License to Robert Gelbard and does hereby direct the Municipal Clerk to forward a certified resolution in notification of the transfer to the New Jersey State Alcohol Beverage Control Commission. Once endorsed the Municipal Clerk will hold the license until said licensee finds a location, at which time an amendment to the application will be made.
