ORDINANCE NO. 23-12

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER TO AUTHORIZE THE PRIVATE SALE OF PERSONAL PROPERTY NO LONGER NEEDED FOR PUBLIC USE, SPECIFICALLY BICYCLES, TO THE BOYS AND GIRLS CLUB OF TRENTON AND MERCER COUNTY, A 501(c)(3) NON-PROFIT ORGANIZATION

WHEREAS, the Township Council determines that the following personal property owned by the Township, consisting of bicycles no longer needed for municipal purposes by the Township of Ewing:

Bicycles

Approximately 43 bicycles of various types that have been collected and/or provided to the Township over time (see attached list)

WHEREAS, pursuant to N.J.S.A. 40A:12-21.1, the Township Council authorizes the private sale of such personal property for nominal consideration to any organization listed in N.J.S.A. 40A:12-21; and

WHEREAS, The Boys and Girls Club of Trenton and Mercer County is an approved 501(c)(3) not-for-profit charity formed to enable all young people, especially those most in need, to reach their full potential as productive, caring, and responsible citizens; and

WHEREAS, pursuant to N.J.S.A. 40A:12-21(k), The Boys and Girls Club of Trenton and Mercer County meets the definition of an organization to which municipalities may make private sales of personal property for nominal consideration.

NOW THEREFORE BE IT ORDAINED by the Township Council of the Township of Ewing, as follows:

Section 1.

The following personal property owned by the Township of Ewing, consisting of bicycles, which is no longer needed for municipal purposes by the Township of Ewing:

Bicycles

Approximately 43 bicycles of various types that have been collected and/or provided to the Township over time (see attached list)

shall be sold pursuant to N.J.S.A. 40A:12-21.1 and N.J.S.A. 40A:12-21(k) to The Boys and Girls Club of Trenton and Mercer County for a nominal consideration of \$1.00.

Section 2.

This Ordinance shall take effect as provided by law.
