The Clerk stated for the record that Ms. Keyes-Maloney has an excused absence and President Wollert will be here later.

PRESENTATION – Youth Week – Jim Castelize, III (Leading Knight – First Vice President – Trenton Elks 105)

Vice President Baxter said that a presentation was scheduled to start the meeting, but it will be moved to later in the meeting as the participant is not here yet.

DISCUSSION

1. **BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY, APPROPRIATING \$2,000,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$1,900,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF**

Vice President Baxter said that this is in conjunction with the Township Budget that was just adopted. It is the Capital side of it. This will approve funding for the Capital projects listed within the Ordinance. There is a de minimis change in Section J. It says Emergency Management Services; it should be Emergency Medical Services. The Attorney confirmed that that is the only change. It is minor. Everything else in Section J stands.

There were no questions or comments from Council.

Victoria Mark (Glendale section of Ewing) asked if these have already been approved by Council?

Vice President Baxter responded that some of that Capital you saw Council approve earlier this year was from last year. This year’s Capital will be spent going forward. Councilwoman Steward added that some of the Capital items mentioned during the budget presentations are in this Bond Ordinance which authorizes the borrowing of

funds to pay for those items. You will also hear about these same items when Council authorizes their purchase.

Ms. Mark (Glendale section of Ewing) asked what will happen to the old computers that are being replaced?

The Vice President replied that they are either auctioned off or disposed of after it comes before Council.

Ms. Mark asked how can she be a part of that, so she knows what is going on?

Vice President Baxter replied that it is not sold directly to the Public, it is auctioned.

The Vice President, Councilwoman Steward, and the Administrator explained the process further.

There were no additional questions or comments from the Public.

2. A RESOLUTION AUTHORIZING THE SUBMISSION OF THE EWING (EDAA) MUNICIPAL ALLIANCE GRANT FOR THE GOVERNOR'S COUNCIL ON ALCOHOLISM AND DRUG ABUSE FISCAL GRANT CYCLE JULY 2020-JUNE 2025

Vice President Baxter said that the Township does this annually. Why does it say July 2020-June 2025?

Councilwoman Steward replied that she believes that that is the name of the grant program. The Township is applying for 2023-2024.

The Vice President said that the Council does their part to keep the Township Drug & Alcohol Alliance going. There is also an in-kind contribution, and a Cash Match. The Governor's Council is \$13,111.00, the Cash Match is \$3,277.75, and In-Kind is \$9,833.25.

Councilwoman Steward added that this is done annually to support the Municipal Alliance and the work they do to educate young people about drug and alcohol abuse.

There were no questions or comments from Council.

Victoria Mark (Glendale section of Ewing) said that she could not hear the dollar amounts.

Councilwoman Steward repeated the dollar amounts.

STATEMENTS AND COMMENTS FROM MEMBERS OF THE PUBLIC

Jim Cardanni (124 Honeysuckle Drive) asked if the Township is aware of any road improvements being done by Hopewell to Federal City Road. The Administrator responded that Ewing, Hopewell, and Lawrence have agreed to fund the traffic light at the intersection of Federal City Road and Bull Run Road. However, there is a dispute as to where it should go. Lawrence had agreed to maintain the light. A light cost about \$250,000.00. When Ewing recently repaved the road, it was stripped tighter, and the speed limit was put on the road to try to slow traffic. It is a Hopewell development; both Ewing and Lawrence were not happy with it mostly because Hopewell was not cooperative initially.

Sara Hendrickson (481 Walker Avenue) said that the Township always gets grant money for a football field or a basketball field. But there is never money for the creek. The slop she sees in the creek is awful. Why does the Township not get grant money for the creek after storms? The Administrator responded said that he has spoken to Ms. Hendrickson about this a lot. There is a debate. The DEP says to leave it alone, to let nature take its course. The Administrator said that he is not touching it because the Town would get fined. Ms. Hendrickson and he disagree on the DEP's determination, so she has cleaned up a lot of stuff. Years ago, the Township Engineer did a full cleanup of the stream including embankment work. It collects on the old driving range on Prospect Street which is privately owned. The Administrator said that, at the request of Ms. Hendrickson, he spoke with the owner today. The owner will start cutting the grass again. Anything that washes down, washes into the creek.

The Township had not applied for grant money because the last time the Township cleaned up along the creek, which was last year, it was flowing properly. People are allowing things to go into the storm drains. The person on Stokes has been reported to the DEP. He is being cited.

Ms. Hendrickson added that the cabana and sheds on Rosedale Avenue are too close to the creek. They should be twenty-five feet from it.

The Administrator said he received those pictures.

Ms. Hendrickson mentioned that Colonial Lake in Lawrence cannot get the trash out of the lake. Can the Fire Company practice using their new equipment by helping them get the trash out?

Ron Prykanowski (16 Thurston Avenue) said that every year the Knights of Columbus honors a member of the military for their service to the country and the community. This year's honoree is General Bob Dutko from Ewing. Mr. Prykanowski is sending the pertinent information to the Clerk. General Dutko served honorably. Besides his work with the Ewing Patriotic Committee, he has also done a lot outside of Ewing. He will be honored June 11th at Mercer Oaks.

Vice President Baxter asked about the ticket price.

Mr. Prykanowski replied that there will not be any tickets. It is \$50 per head.

Sara Hendrickson (481 Walker Avenue) asked what is going on with Crab du Jour.

The Administrator replied that he is having trouble staying open.

Ms. Hendrickson stated that that stuff cannot be left in the creek.

The Administrator explained the situation which had been going on for thirteen years.

Ms. Hendrickson said that it has been too long and then asked about the status of the laundromat next to the Ewing Diner. Has it ever been cleaned-up?

The Administrator said that that is all part of the DEP clean-up. The Township was told not to touch it. The DEP says that it is clean.

Victoria Mark (Glendale section of Ewing) asked, what is the next step? What can Ewing do? How does the Town get the DEP to move along?

The Administrator said that the only thing is to contact the DEP and ask for an update. He had contacted the DEP in the fall of last year.

Ms. Mark commented – so seven months later, the Administrator is going to follow-up on it.

Vice President Baxter said that this is administrative. Council does not have power over this. You can set up a meeting to discuss this with the Administration.

WHEREAS, the Township of Ewing (the "Township") supports providing residents and students with pedestrian safety near Antheil Elementary School; and

WHEREAS, the Township considers pedestrian safety to of significant importance to the Township; and

WHEREAS, Mercer County is asking for no on street parking on certain areas of Ewingville Road (CR 636) as a part of the Antheil Elementary School Pedestrian Safety and Bus Circulation Plan; and

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Township of Ewing, County of Mercer that the Code of the Township of Ewing be amended as follows:

Section 1 Chapter 225, VEHICLES AND PARKING, Article VIII, SCHEDULES, Section 48, Schedule I: NO PARKING ANYTIME is hereby amended as follows:

Section 2 Severability. Should any section, clause, sentence, phrase or provision of this article be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this article.

Section 3 Repealer. All prior ordinances or parts of the same inconsistent with any provisions of this article are hereby repealed to the extent of such inconsistency.

Section 4 Effective Date. This ordinance shall take effect upon final adoption and publication in accordance with law.
