AN ORDINANCE AMENDING THE EWING TOWNSHIP SALARY ORDINANCE ESTABLISHING COMPENSATION OF OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF EWING

BE IT ORDAINED by the Township Council of the Township of Ewing that the Salary Ordinance establishing compensation of Officers and Employees of the Township of Ewing for the calendar year 1/1/2024 – 12/31/2024 is hereby amended as follows:

Section 1. The following Salaries are hereby established for the compensation of Officers and Employees for the fiscal year 1/1/2024 – 12/31/2024:

Section 2. In addition to the Salaries payable, all employees not covered by a collective bargaining agreement, except for elected officials, shall be subject to the terms and conditions of the collective bargaining agreement Local 102 of the International Brotherhood of Electrical Workers A.F.L. – C.I.O., including all future salary increases in accordance with the schedule set forth in such agreement, unless otherwise provided for in a separate contract with the employee. All other employees of the Township, who are members of a collective bargaining agreement, shall be paid in accordance with and are subject to the terms and conditions of their applicable collective bargaining agreement.

Section 3. The following employees are subject to an individual employment contract that has been adopted by the Ewing Township Council, which are incorporated herein by reference: Chief of Police, Deputy Chief of Police and Municipal Court Judge.

Section 4. This Ordinance shall be effective January 1, 2024 and shall take effect upon final passage and publication according to law.

This Ordinance amends the Salary Ordinance of the Township of Ewing for the position of the Municipal Clerk, Township Administrator, Fire Director, Chief of Police, Deputy Chief of Police and Municipal Court Judge.

**ORDINANCE OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER,
NEW JERSEY AUTHORIZING THE CONVEYANCE OF PROPERTY TO
REDEVELOPER**

WHEREAS, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 *et seq.* (the “**Redevelopment Law**”) authorizes municipalities to determine whether certain parcels of land located therein constitute areas in need of redevelopment; and

WHEREAS, under the Redevelopment Law, the Township Council (the “**Township Council**”) of the Township adopted Resolution No. 11R-154 on July 26, 2011, designating the properties located at Block 343, Lot 1.01, Block 374, Lot 4.02 and Block 365, Lot 9 on the Township’s tax map (collectively, the “**Original Parkway Avenue Redevelopment Area**”) as an area in need of redevelopment; and

WHEREAS, on January 29, 2013, the Township Council adopted Ordinance No. 13-02 approving and adopting a redevelopment plan for the Original Parkway Avenue Redevelopment Area (the “**Original Redevelopment Plan**”); and

WHEREAS, the Township Council subsequently adopted a resolution designating the properties located at Block 374, Lot 3 and 365, Lot 21 as an area in need of redevelopment and adding them to the Original Parkway Avenue Redevelopment Area (as amended, the “**Parkway Avenue Redevelopment Area**”); and

WHEREAS, on March 8, 2022, the Township Council adopted Ordinance No. 22-06 approving and adopting an amended redevelopment plan for the Parkway Avenue Redevelopment Area (the “**Redevelopment Plan**”); and

WHEREAS, in accordance with Section 65 of the Township Code, the Ewing Township Redevelopment Agency (the “**Agency**”) is the redevelopment entity responsible for implementing the Redevelopment Plan; and

WHEREAS, KRE Acquisitions Corp., or an affiliate thereof (“**KRE**”), owns the portion of the Parkway Avenue Redevelopment Area designated as a portion of Block 374, Lot 4.02 and known generally as 1500 Parkway Avenue (the “**KRE Property**”); and

WHEREAS, on October 5, 2022, the Agency adopted a resolution designating KRE as the redeveloper for the KRE Property and authorizing the execution of a redevelopment agreement in connection with the redevelopment thereof and KRE proposes to redevelop same together with that portion of Block 374, Lot 4.02 owned by the Township (the “**Township Property**”); and

WHEREAS, the Agency and KRE executed a redevelopment agreement, dated October 31, 2022 (the “**Redevelopment Agreement**”), pursuant to which KRE agreed to redevelop the KRE Property, together with the Township Property, by constructing thereon a project consisting of an approximately 285,440 square foot warehouse, along with three flex buildings of approximately 20,000 square feet each, and supportive parking and other improvements (the “**Redevelopment Project**”); and

WHEREAS, the Purchaser proposes to acquire the Township Property and consolidate same with the KRE Property to construct the Redevelopment Project in accordance with the Redevelopment Agreement; and

WHEREAS, the Township has determined that the Township Property is no longer needed for public use, and that the merger of the Township Property into the KRE Property is in the Township’s best interest; and

WHEREAS, the Township desires to convey the Township Property to KRE for the purpose of merging same into the KRE Property and facilitating the construction of the Redevelopment Project, and to execute a contract with KRE (the “**Contract**”) in connection with such conveyance.

NOW THEREFORE, BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF EWING, IN THE COUNTY OF MERCER, NEW JERSEY, AS FOLLOWS:

1. The aforementioned recitals hereof are incorporated herein as though set forth at length.
2. The Township is hereby authorized to convey the Township Property to KRE (or an affiliated entity thereof) for One Dollar (\$1.00), in accordance with the terms and conditions set forth in a Contract, in furtherance of the Redevelopment Plan.
3. The Mayor is hereby authorized and directed to execute the Contract in substantially the same form as that attached hereto as **Exhibit A**, together with such additions, deletions, and other modifications deemed necessary upon consultation with counsel to the Township and other appropriate professionals, and prepare, amend, or execute any other agreements necessary to effectuate this ordinance, subject to modification or revisions as deemed necessary and appropriate.
4. The Mayor and Township Clerk are hereby authorized to take such action and to execute such other documents, on behalf of the Township, in consultation with Township counsel and other appropriate professionals, as is necessary to effectuate the terms of this ordinance and the conveyance of the Township Property.
5. This ordinance shall take effect in accordance with applicable law.

A RESOLUTION OF THE TOWNSHIP OF EWING DEMONSTRATING PROOF OF LOCAL SUPPORT FOR THE SUITABILITY OF A CANNABIS MANUFACTURING AND CULTIVATION FACILITY, OPERATED BY GREEN ROOM GOODS AT 225 PHILLIPS BLVD., BLOCK 225.02, LOT 54 EWING, NJ 08638

Resolution #24R- WHEREAS, the New Jersey Jake Honig Compassionate Use Medical Cannabis Act, N.J.S.A. 24:6I-2, *et seq.*, and accompanying regulations, N.J.A.C. 17:30A-1, *et seq.*, authorize medical use and possession of cannabis, and related operations, and the New Jersey Cannabis Regulatory, Enforcement, Assistance, and Marketplace Modernization Act (the “Adult Use Act”), N.J.S.A. 24:6I-31, *et seq.*, and accompanying regulations, N.J.A.C. 17:30-1, *et seq.*, authorize the adult use and possession of cannabis, and related operations (collectively the “Cannabis Laws”); and

WHEREAS, the Township of Ewing (the “Township”) previously endorsed the expansion of medical and adult use cannabis in the State of New Jersey, and supports safe and appropriate siting of cannabis related and supporting businesses within the Township, including medical and adult use cannabis businesses; and

WHEREAS, Green Room Goods (the “Applicant”) seeks to hold a Class 2 Cannabis Manufacturer license and a Class 1 Cultivator license for the manufacturing and cultivation of cannabis products within the Township; and

WHEREAS, the Applicant seeks to operate a cannabis manufacturing and cultivation facility at 225 Phillips Blvd., Block 225.02, Lot 54, Ewing, NJ 08638 (the “Property”); and

WHEREAS, Phillips Blvd. is a previously approved location for Cannabis manufacturing and cultivation such that this application is consistent with the newly adopted cannabis moratorium, Resolution #23R-66; and

WHEREAS, an applicant for an annual cannabis business license must submit, among other requirements, proof of local support in accordance with N.J.A.C. 17:30-7.10(b)(9); and

WHEREAS, pursuant to N.J.A.C. 17:30-5.1(g), a municipality may demonstrate proof of local support for the suitability of a cannabis business’s proposed location by indicating that the intended location is appropriately located or otherwise suitable for activities related to the operations of the proposed cannabis business with the adoption of a resolution by the governing body; and

WHEREAS, the Township Cannabis Advisory Committee (“CAC”) has reviewed the Cannabis Local License Application submitted by the Applicant for the cultivation and manufacturing of cannabis and cannabis products at the Property within the Township; and

WHEREAS, the CAC recommends approval and endorsement of the application submitted by Green Room Goods subject to the reasonable time, place, and manner restrictions imposed by the lawfully enacted Ordinances of the Township, including but not limited to Ordinance No. 21-16 (the “Cannabis Ordinance”).

NOW THEREFORE, BE IT RESOLVED, by the Ewing Township Council that:

1. Green Room Goods (the “Applicant”) seeks to operate a cannabis manufacturing and cultivation facility at 225 Phillips Blvd., Block 225.02, Lot 54, Ewing, NJ 08638 (the “Property”), which is located in an area designated for such permitted conditional uses.
2. The Township recognizes not only the suitability of such operations at the Property, but also the benefits a company such as Green Room Goods. would bring to our community as a whole, including, but not limited to, job creation, job training to help reverse the stains on the community by the war on drugs, use of local vendors for build-out and ongoing operational needs, as well as anticipated dedicated tax revenues from each sale at any cannabis dispensary located within Township.
3. The Cannabis Ordinance indicates that the operation of a cultivation and manufacturing facility at the Property is consistent with the zoning rules identified therein. Specifically, Class 1 Cannabis Cultivation and Class 2 Cannabis Manufacturer licenses are a permitted conditional use in the Olden Avenue Redevelopment Area, Parkway Avenue Redevelopment Plan, and Industrial Park-1 (IP-1) and Industrial Park-3 (IP-3) zones.
4. The issuance of a Class 2 Cannabis Manufacturer license and a Class 1 Cultivator license by the CRC would not exceed a license limitation for these types of licenses within the Township and further, this application seeks to locate at the previously approved Phillips Blvd. location such that this application is consistent with the newly adopted cannabis moratorium by way of Resolution #23R-66.
5. Based on the preceding, the Township is satisfied not only that the Property the Applicant seeks to utilize is compliant with the Township’s zoning rules and requirements outlined by the Cannabis Ordinance, but also that the Applicant will be a valuable addition to the group of cannabis license holders awarded by the CRC, and that its business operations will have a positive impact on the Township and community at large.

6. In light of that, and in the event that the CRC issues the Applicant a Class 2 Cannabis Manufacturer license and a Class 1 Cultivator license in accordance with the Cannabis Laws, this Resolution should be viewed by the State as unequivocal support by the Township of the Applicant, Green Room Goods, and an indication that the intended location is appropriately located or otherwise suitable for the activities related to the manufacturing of cannabis, cannabis products, and related supplies as will be conducted at the proposed facilities.
7. The Township also authorizes the Township Zoning Official to issue any required letter or affidavit identifying that the proposed facility will conform to local zoning requirements allowing for activities related to the operation of a manufacturing facility, as outlined in the Cannabis Ordinance, subject to the understanding and agreement with the Applicants that they will comply with any reasonable additional zoning requirements imposed by the Township, which the Township understands and agrees will not occur until after the Applicants obtain preliminary approval by the CRC, and subject to any additional permitting requirements that the Township will impose in accordance with the Cannabis Ordinance.
8. This Resolution shall take effect immediately.


