## TOWNSHIP OF FAIRFIELD ESSEX COUNTY, NEW JERSEY ORDINANCE #2024-03

# AN ORDINANCE OF THE TOWNSHIP OF FAIRFIELD, ESSEX COUNTY, NEW JERSEY AMENDING CHAPTER 17, SEWERS, OF THE TOWNSHIP CODE

**WHEREAS**, the Governing Body of the Township of Fairfield desires to amend the Sewers Ordinance section of the Township Code.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Township Council of the Township of Fairfield, County of Essex, State of New Jersey, as follows:

**SECTION** 1. §17-5.1a, entitled "Fees and Charges", of the Township Code of the Township of Fairfield is hereby amended to read as follows: (All additions are shown in <u>bold italics with</u> <u>underlines.</u> The deletions are shown as <u>strikeovers in bold italics</u>.)

a. There is hereby established the following schedule of public sewer charges for the connection, inspection and use of the public sewer system:

1. The minimum charge per quarter shall be based upon a water usage of 15,000 gallons per quarter, with an additional charge of \$17.5018.00 per 1,000 gallons for use in excess of 15,000 gallons per quarter. The charge for each quarter, however, shall be based upon the water usage for the first quarter of that particular year as indicated by the water meter reading; unless, in the

opinion of the Municipal Engineer, water usage from another quarter or portion of quarter provides a better basis for setting the sewer use charge for the year in question.

2. In industrial and commercial establishments which are not connected to the water system but are connected to the sewer system, a meter will be furnished by the Township at the owner's expense at the costs set forth below, with installation of the meter at the owner's own cost and expense. Meters shall be charged in accordance with the following schedule:

**SECTION 2**. All actions of the Township taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

**SECTION 3.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any remaining part thereof.

**SECTION 4.** All Ordinances or parts of Ordinances of the Township of Fairfield heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 5**. This Ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
