TOWNSHIP OF FAIRFIELD ORDINANCE #2023-21

AN ORDINANCE OF THE TOWNSHIP OF FAIRFIELD, ESSEX COUNTY, NEW JERSEY AMENDING CHAPTER 4, CANNABIS ESTABLISHMENTS, SECTION 4-24.4, LICENSE FEE, OF THE TOWNSHIP CODE

WHEREAS, the Governing Body of the Township of Fairfield desires to amend the section of the Code referenced above regarding licensing fees for Cannabis Distributor, Cannabis Manufacturer and Cannabis Wholesaler uses in the Township.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Council of the Township of Fairfield, County of Essex, State of New Jersey, as follows:

SECTION 1. Chapter 4, entitled "Cannabis Establishments", Section 4-24.4, entitled "License Fee", of the Township Code of the Township of Fairfield is hereby amended to read as follows: (All additions are shown in *bold italics with underlines*. The deletions are shown as *strikeovers in bold italics*.)

4-24.4 License Fee.

The fee for a Cannabis Distributor, Cannabis Manufacturer, or Cannabis Wholesaler License shall be five hundred <u>ten thousand</u> dollars (\$5<u>10,000</u>.00). The annual renewal fee for a Cannabis Distributor, Cannabis Manufacturer, or Cannabis Wholesaler license shall be <u>five hundred</u> <u>ten thousand</u> dollars (\$5<u>10,000</u>.00).

SECTION 2. All actions of the Township taken prior to the date of adoption hereof contemplated by this Ordinance are hereby ratified and approved.

SECTION 3. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any remaining part thereof.

SECTION 4. All Ordinances or parts of Ordinances of the Township of Fairfield heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5. This Ordinance shall take effect immediately upon its final passage, approval and publication as provided by law.
