§98-27 (H) to read as follows*:

- (H) Bernard Street is located within two zoning areas: residential and commercial. Bernard Street in the residential portion of the Village shall be two-way street where the northerly end interfaces with Prospect Street; Bernard Street shall be both inbound and out bound from/to Prospect Street. A sign indicating where the two-way traffic (residential portion of Bernard Street) ends, and one-way traffic on Bernard Street begins shall be posted. On street parking in the residential portion of Bernard Street shall be as follows: Vehicles on the East Side of Bernard Street shall be parked in a northerly direction (toward Prospect Street); Vehicles on the West Side of Bernard Street shall be parked shall be in a southerly direction (toward Fulton Street). The commercial portion of Bernard Street shall be one-way street in a southerly direction to Fulton Street (New York State Route 109) from the two-way portion of Bernard Street. The

southerly end of Bernard Street at its intersection with NY 109 (Fulton Street) will be a one-way (exit only) onto NY 109 (Fulton Street). There shall be no parking on either side of Bernard Street in the commercial portion of Bernard Street. No parking signs shall be posted. There shall be no entrance onto Bernard Street from NY 109 (Fulton Street). "Do Not Enter" signs shall be posted at the intersection between NY 109 (Fulton Street) and Bernard Street. One-way signs shall also be posted in the commercial area toward Fulton.

**§98-27 (A) - (G) and (I) - (L) shall remain unchanged.*




