ORDINANCE: O-2024-02-R

AN ORDINANCE OF THE BOROUGH OF FANWOOD, COUNTY OF UNION, AND STATE OF NEW JERSEY AMENDING CHAPTER 280 PROHIBITING PARKING ON TILLOTSON ROAD

WHEREAS, the Borough of Fanwood ("the Borough") wishes to insure safety and access of emergency vehicles and the orderly flow of traffic within the jurisdiction of the Borough; and

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Fanwood, County of Union, State of New Jersey as follows:

- I. Chapter 280-47 is hereby amended as follows:
 - A. Vehicles, except trucks, trailers or buses over 9,000 pounds' gross vehicle weight which are governed by § 280-47B. In accordance with the provisions of § 280-11A, no person shall park a vehicle between the hours listed upon any of the following streets or parts of streets:

II. If any clause, sentence, paragraph, section or part of this ordinance or any other codes or ordinances incorporated herein shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which said judgment shall have been rendered.

III. This ordinance shall become effective twenty (20) days after its final passage.

BE IT FURTHER ORDAINED this section of 280-47 shall take effect as provided by

law.
