

# BOROUGH OF FANWOOD, UNION COUNTY, NEW JERSEY

ORDINANCE: 2025-13 R

## AN ORDINANCE OF THE BOROUGH OF FANWOOD, COUNTY OF UNION, AND STATE OF NEW JERSEY AMENDING CHAPTER 118 OF THE BOROUGH CODE REGARDING LICENSE FEES FOR CHICKENS

**WHEREAS**, the Borough of Fanwood maintains Chapter 118, covering the requirements and regulations of animals within the Borough; and

**WHEREAS**, the Borough of Fanwood wishes to enact certain licensing requirements for chickens maintained within the jurisdiction of the Borough;

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of Fanwood, County of Union, State of New Jersey as follows:

I. Chapter 118-28 (C)(2) is hereby amended as follows:

(2) Permits are issued annually and expire at the end of each calendar year. New permits may be applied for at any time during the year. Permit renewals may be made after December 1 for the following calendar year. An annual fee of \$25.00 per chicken shall be charged and collected by the Borough Clerk.

II. If any section, sub-section, paragraph, sentence, or any other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance.

III. All Ordinances or parts of Ordinances that are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

IV. This Ordinance shall take effect twenty (20) days after final passage and publication as prescribed by law.
