

ORDINANCE NO. 2024- 3

FALLS TOWNSHIP, BUCKS COUNTY, PENNSYLVANIA

AN ORDINANCE AMENDING THAT CHAPTER 203 – “VEHICLES AND TRAFFIC,” ARTICLE III – “PARKING REGULATIONS,” SECTION 22 – “PARKING PROHIBITED AT ALL TIMES”, SUBSECTION C, AND CHAPTER 203 – “VEHICLES AND TRAFFIC,” ARTICLE III – “PARKING REGULATIONS,” SECTION 23 – “PARKING PROHIBITED DURING CERTAIN HOURS”, SUBSECTION A

WHEREAS, the Falls Township is a duly organized Township of the second class, existing and operating in accordance with the laws of the Commonwealth of Pennsylvania; and

WHEREAS, the Township is vested with certain corporate powers, including the adoption of all such ordinances, by-laws, rules and regulations, deemed necessary by the Township for the proper management and control of the Township, and maintenance of peace and the public welfare of the Township and its residents; and

WHEREAS, the Township has determined that Chapter 203 – “Vehicles and Traffic,” Article III – “Parking Regulations,” Section 203-22 – “Parking prohibited at all times”, Subsection C, and Chapter 203 – “Vehicles and Traffic,” Article III – “Parking Regulations,” Section 203-23 – “Parking prohibited during certain hours”, Subsection A should be amended for the health, safety, and general welfare of the Township and the inhabitants thereof.

NOW, THEREFORE, the Board of Supervisors of the Township of Falls, County of Bucks, Commonwealth of Pennsylvania, does hereby **ENACT** and **ORDAIN** as follows:

- I. Chapter 203 – “Vehicles and Traffic,” Article III – “Parking Regulations,” Section 203-22 – “Parking prohibited at all times”, Subsection C shall be amended to remove the following restrictions:

Name of Highway	Side	Location
Vermillion Way	East	From Trenton Road to Vermont Lane

Vermillion Way

West South

From Trenton Road to a point  
300 feet south thereof

- II. Chapter 203 – “Vehicles and Traffic,” Article III – “Parking Regulations,” Section 203-23 – “Parking prohibited during certain hours”, Subsection A shall be amended to **remove** the following restrictions:

Barberry Lane	Permit parking only during school hours	Both	From Black Pine Lane to Buttonwood Lane
Buttonwood Lane	Permit parking only during school hours	North	No. 88 Buttonwood Lane only
Bluespruce Lane	Permit parking only during school hours	North	From Birch Drive to and including address No. 82
Bluespruce Lane	Permit parking only during school hours	South	From address No. 101 to and including address No. 69
Briarroot Lane	Permit parking only during school hours	North	From Birch Drive to and including address No. 80
Briarroot Lane	Permit parking only during school hours	South	From Birch Drive to and including address No. 75
Black Pine Lane	Permit parking only during school hours	North	From Upper Birch Drive to and including No. 42
Black Pine Lane	Permit parking only during school hours	South	From Upper Birch Drive to and including No. 37
Upper Bird Drive	Permit parking only during school hours	Both	From Black Pine Lane to the Township Line

**III. SEVERABILITY.**

In the event that any section, sentence, clause, phrase or word of this ordinance shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent or otherwise foreclose enforcement of any of the remaining portions of this ordinance. If there are any inconsistencies between the provisions of this Ordinance and any other section of the Administrative Code in effect, the terms and provisions of this Ordinance shall control.


**IV. REPEALER.**

All ordinances or parts of ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.


**V. EFFECTIVE DATE.**

This Ordinance shall be effective five (5) days after it has been approved by the Board Chair, or in default thereof, five (5) days after it is deemed approved by operation of law.
