#### **ORDINANCE NO. 2659-2023**

AN ORDINANCE TO AMEND CHAPTER 94, FEES, ARTICLE IV, COSMETOLOGY AND HAIRSTYLING ESTABLISHMENT INSPECTIONS OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 94, Fees, Article IV, Cosmetology and Hairstyling Establishment Inspections is hereby amended and supplemented by inserting the text <u>underlined and marked in bold</u> and deleting the text in **bold strikethrough** as follows:

### Chapter 94. Fees

## Article IV. Cosmetology and Hairstyling Establishment Inspections

## § 94-9 Inspection fees

The following fees are established for the aforesaid inspections:

- A. Initial annual inspection:
  - 1) One to five stations in use: \$35. \$50, if paid within (30) thirty days.
  - 2) Six or more stations in use: \$50. \$100. If paid after (30) thirty days.
- B. Each re-inspection: \$50. Initial re-inspection: \$50.
- C. Each additional re-inspection: \$75.

**SECTION 2:** If any section, paragraph, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 3.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.
