## ORDINANCE NO. 2651-2023

**AN ORDINANCE TO AMEND CHAPTER 241, WATER, ARTICLE IV, RATES AND CHARGES, MORE SPECIFICALLY SECTION 241-50, “WATER RATES” AND SECTION 241-52, “FIXED SERVICE CHARGE – MAIN CHARGE” OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000**

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 241, Water, Article IV, Rates and Charges, Section 241-50, Water Rates, and Section 241-52, Fixed Service Charge – Main Charge, are hereby amended and supplemented by inserting the text **underlined and marked in bold** and deleting the text shown in ~~**bold strikethrough**~~ as follows:

### **Chapter 241. Water**

#### **Article IV. Rates and Charges**

##### **§241-50 Water Rates.**

- A. Water rates where a meter is installed shall be ~~**\$5.60**~~ **\$6.00 per one thousand gallons in calendar year 2023, \$6.25 per one thousand gallons in calendar year 2024 and \$6.50 per one thousand gallons in calendar year 2025.** The water rate is in addition to the minimum fixed service charge as set forth in § 241-52.

##### **§241-52 Fixed Service Charge – Main Charge.**

**SECTION 2:** The water rate and fixed quarterly service charges shall take effect on the second quarter billing scheduled for April 15, 2023.

**SECTION 3:** If any section, paragraph, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to this section, paragraph, clause or provision so adjudged and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 4.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 5.** This Ordinance shall take effect upon passage and publication according to law.
