## ORDINANCE NO. 2655-2023

### AN ORDINANCE FIXING THE SALARIES OF CERTAIN EMPLOYEES OF THE BOROUGH OF FAIR LAWN, BERGEN COUNTY, NEW JERSEY AS AMENDED – PART-TIME POLICE EMPLOYEES

**WHEREAS**, a need has arisen to amend Ordinance 2607-2021, adopted on 12/14/2021.

**NOW, THEREFORE, BE IT ORDAINED**, by the Borough Council of the Borough of Fair Lawn, as follows;

**SECTION 1.** Ordinance 2607-2021 is hereby amended and ratifies the part-time position of Special Law Enforcement Officer Class I, effective 01/01/2023, shall be as follows:

	<u>Min 2023/Max 2023</u>	<u>Min 2024/Max 2024</u>	<u>Min 2025/Max 2025</u>
Special Law Enforcement Officer Class I	\$ 20.50/22.00	\$ 21.00/22.50	\$ 21.50/23.00

**SECTION 2.** That all salaries not covered by this Ordinance will remain effective until amended by further salary ordinances.

**SECTION 3.** Salary increases are effective only if an employee has not resigned voluntarily or has not been terminated with cause. Retired employees are not eligible.

**SECTION 4.** All ordinances inconsistent with the provisions of the Ordinance are hereby repealed to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior Borough ordinances, the provisions hereof shall be determined to govern. All other parts and provisions of the Borough's ordinances are hereby ratified and confirmed, except where inconsistent with the terms hereof.

**SECTION 5.** This Ordinance shall take effect upon passage and publication as required by law.
