#### **ORDINANCE NO. 2660-2023**

# AN ORDINANCE TO AMEND CHAPTER 94, FEES, ARTICLE VI, SCHEDULE OF FEES OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 94, Fees, Article VI, Schedule of Fees is hereby amended and supplemented by inserting the text <u>underlined and marked in bold</u> and deleting the text in **bold strikethrough** as follows:

## § 94-12 Miscellaneous fees

- G. Chapter 111, Food Handling.
  - (1) Section 111-12.
    - a) Food handler's certificate initial registration: for 2013, \$30; for 2014, \$30; for 2015, \$35. \$20. After 14 days of employment or revocation of food handler registration: \$40.
    - b) Renewal fee, annual: \$10. \$20. After January 31: \$40.
    - c) Provisional certificate: no fee.
    - d) [No Change]
    - e) <u>Veteran-owned</u> and <u>Veteran</u> <u>Organization-owned</u> <u>Food</u> <u>Establishments</u> who meets the predetermined criteria based <u>upon a policy set forth by the Borough Manager: No Fee</u>
  - (2) Section 111-16 Special Temporary Food Vendor's Permit
    - a)<del>Non-potentially hazardous foods, per day: \$50.</del> <u>Annually:</u> <u>\$175.</u>
    - b)Potentially hazardous foods, per day: \$100. Per day: \$125.
    - c) Annually: \$150. Non-potentially hazardous prepackaged food only, annually: \$100.
    - d)Prepackaged food, annually: \$80. Non-potentially hazardous prepackaged foods only, per day: \$75.

- e)<del>Veterans: No fee.</del> <u>Temporary retail food establishment</u> <u>kitchen: \$100 per event.</u>
- f) <u>Temporary food vendor's permit for Veteran, Active Military,</u> <u>National Guard or Military Reserve Vendor who meets the</u> <u>predetermined criteria based upon a policy set forth by the</u> <u>Borough Manager: No Fee</u>

**SECTION 3.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** This Ordinance shall take effect upon passage and publication according to law.
