## **ORDINANCE NO. 2675-2023**

## AN ORDINANCE AMENDING FILMING FEES AT CHAPTER 94, <u>FEES</u>, ARTICLE VI, <u>SCHEDULE OF FEES</u>, SECTION 94-12, "MISCELLANEOUS FEES" OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 94, <u>Fees</u>, Article VI, <u>Schedule of Fees</u>, <u>Section 94-12</u>, <u>"Miscellaneous Fees,"</u> is hereby amended and supplemented by inserting the text <u>underlined and marked in bold</u> and deleting the text in **bold strikethrough** as follows:

## Chapter 94. Fees

Article VI. Schedule of Fees

- § 94-12 Miscellaneous fees
- \* \* \*
- FF. <u>Chapter 98, Filming: Filming fees:</u>
- (1) A daily fee of \$500; Basic filming permit: \$100. Where an applicant requests expedited processing of a permit within (24) hours of the filming date, the basic filming permit fee for such expedited processing of the permit application shall be \$150.
- (2) Daily filming fee payable, in addition to the basic filming permit fee, when filming on public property: \$200 per day.
- (3) Daily filming fee payable for a major motion picture, in addition to the basic filming permit fee, when filming on public property: \$1,000 per day.
- (4) Filming for non-profit applicants filming for educational purposes, including student films: No fee
- (5) Filming on private property: No fee

(6) The Borough shall also be reimbursed by the filming company for the costs incurred by the Borough for equipment and Borough oversight for all filming activities, <u>including but not limited to police officers, fire personnel</u> and employees of the Department of Public Works.

**SECTION 2:** If any section, paragraph, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged, and the remainder of the Ordinance shall be deemed valid and effective.

**SECTION 3.** All ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** This Ordinance shall take effect upon passage and publication according to law.
