ORDINANCE NO. 2680-2023

AN ORDINANCE TO AMEND CHAPTER 232, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, MORE SPECIFICALLY SECTION 232-11, "PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS" OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF FAIR LAWN, 2000

NOW THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Fair Lawn as follows:

SECTION 1. Chapter 232, Vehicles and Traffic, Article II, Parking, Section 232-11, Parking Prohibited during Certain Hours on Certain Streets is hereby amended and supplemented by inserting the text underlined and marked in bold to read as follows:

§232-11 Parking Prohibited during Certain Hours on Certain Streets

No person shall park a vehicle on a public street or municipal parking area in the Borough between the hours specified and the days specified as follows:

F. Between 12:00 p.m. and 3:00 p.m. prevailing time:

SECTION 2. All other Ordinances, codes or parts thereof that are in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any other prior Borough Ordinances, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Borough's Ordinances are hereby ratified and confirmed, except where inconsistent with the terms hereof.

SECTION 3. Each section of this Ordinance and every subsection hereof shall be deemed independent, separate and distinct from all other sections, and the holding of any section or a part hereof to be unconstitutional, void, or in effective for any cause shall not be deemed to affect the validity or unconstitutionality of any other section or part hereof, and to this end, the provisions of this Ordinance are hereby declared severable.

SECTION 4. This Ordinance shall take effect upon passage and publication as required by law.
