### **ORDINANCE NO. 2691-2024**

## AN ORDINANCE TO AMEND CHAPTER 33, <u>POLICE DEPARTMENT</u>, ARTICLE XVIII, <u>SPECIAL LAW</u> <u>ENFORCEMENT OFFICER – CLASS III</u>, OF THE CODE OF THE BOROUGH OF FAIR LAWN 2000

**NOW THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Fair Lawn as follows:

**SECTION 1.** Chapter 33, Police Department, Article XVIII, Special Law Enforcement Officer – Class III, is hereby amended and supplemented by deleting the text shown in **bold strikethrough** and inserting the text **underlined and marked in bold** as follows:

## §33-60 Uniforms

The uniform of Special Lawn Enforcement Officers Class III shall be determined by the Chief of Police and shall be in compliance with N.J.S.A. 40A:14-146.12.

The Borough shall provide to new Employees, free of charge and in lieu of any additional allowance therefore, all items of Special Law Enforcement Officer Class III uniform and equipment it requires the Employees to wear or utilize in the course of his/her duty assignments. This shall not apply to civilian clothing required for training or to such civilian clothing permitted to be worn.

Thereafter, the Borough will provide an allowance which shall be for the purpose of replacing any and all items as they become damaged, worn out or otherwise unserviceable, and it shall be the responsibility of each Employee to have at all times a complete and minimum inventory of such equipment and clothing as required by uniform regulations. The annual uniform allowance shall be the following:

<u>2024</u>	<u>Two-Thousand Dollars (\$2,000.00)</u>
<u>2025</u>	<u>Two-Thousand Dollars (\$2,000.00)</u>
<u>2026</u>	<u>Two-Thousand Dollars(\$2,000.00)</u>

<u>The Borough shall issue a check to each Employee no later than April 15<sup>th</sup> of each</u> <u>year.</u> This Ordinance shall take effect upon passage and publication as required by law.
