ORDINANCE NO. 2 - 2022

TOWNSHIP OF FAIRFIELD

AN ORDINANCE OF THE TOWNSHIP OF FAIRFIELD AUTHORIZING THE SALE OF MUNICIPALLY OWNED PROPERTIES

WHEREAS, the Township of Fairfield (the "Township") owns thirty-seven (37) properties identified on the attached list (Exhibit "A") and further identified on the Tax Map of Fairfield Township, Cumberland County (hereinafter "Property"); and

WHEREAS, it has been determined by the Township Engineer that there is no public purpose for the Township to retain the Property; and

WHEREAS, pursuant to the New Jersey Local Land and Buildings Law, <u>N.J.S.A.</u> 40A:12-13 and <u>N.J.S.A.</u> 40A:12-13(b)(5), et seq. (the "Law"), the Township, as a municipality governed by the Law, has the legal right to sell any real property, not needed for a public use; and

WHEREAS, all ordinances of the Township of Fairfield which are inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency; and

WHEREAS, if any subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid in any Court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance; and

WHEREAS, this Ordinance shall take effect upon final passage, approval, and publication, as required by law.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Fairfield, County of Cumberland, State of New Jersey, that the Township is authorized to sell the Properties identified on the attached Exhibit "A."; and

BE IT FURTHER ORDAINED that the Mayor, Township Administrator and/or other appropriate Township officials are hereby authorized to take all actions to complete these transactions including, but not limited to execution of an Agreement of Sale and Deed for the Property.
