LOCAL LAW No. 5, 2022 TOWN OF FABIUS, ABOLISHING THE TOWN OF FABIUS PLANNING BOARD AND AMENDING PORTIONS OF THE TOWN OF FABIUS ZONING AND SUBDIVISION CODES

1. Authority

This local law is adopted pursuant to sections 261 - 263 of the Town Law and section 20 of the Municipal Home Rule Law of the State of New York, which authorize the Town to adopt the zoning provisions to advance and protect the health, safety and welfare of the community.

2. Statement of Purpose

The Planning Board of the Town of Fabius has met minimally over the past several years due to the lack of applications, primarily for subdivision and also for special permits and site plans. Under New York State law there is no requirement for a town to create or maintain a Planning Board but state law does require a town to have a Zoning Board of Appeals.

The Town Board is concerned about the cost of maintaining the Planning Board, it,s legal counsel and engineers under the current situation. The Town has in the past and will continue to consolidate government services such as the position of Tax Collector and one Town Justice position to the extent that it does not reduce services and makes the process more efficient and effective for the residents of the Town. The Town Board believes that the Planning Board should be dissolved and its responsibilities transferred to the Zoning Board of Appeals.

3. Planning Board Dissolved

As of the effective date of this local law, the Planning Board of the Town of Fabius is hereby dissolved and its duties are assumed by and transferred to the Zoning Board of Appeals of the Town of Fabius

4. Modifications To Existing Town Laws And Regulations

- A. Town of Fabius Land Subdivision Regulations developed by the Fabius Town Planning Board January 1987 are amended as follows:
- Article 1 Zoning Board of Appeals is substituted for the Planning Board.
- Article 2 Zoning Board of Appeals is substituted for the Planning Board.
- Article 3 Zoning Board of Appeals is substituted for the Planning Board.
- Article 5 Zoning Board of Appeals is substituted for the Planning Board.
- Article 6 Zoning Board of Appeals is substituted for the Planning Board.
- Article 7 Zoning Board of Appeals is substituted for the Planning Board.
- Article 9 Zoning Board of Appeals is substituted for the Planning Board.
- B. Chapter 150 of the Fabius Code, Zoning, is amended as follows;
- 1) Section 150-21, Site Plan Review, Zoning Board of Appeals is substituted for the Planning Board.
- 2) Section 150-23, Special Use Permit, Zoning Board of Appeals is substituted for the Planning Board.
- 3) Section 150 28, Nonconforming Uses, Zoning Board of Appeals is substituted for the Planning Board.
- 4) Section 150-40, Planning Board created, this section is deleted in its entirety.
- C. Local Law, Number 1 of 2022, a local law amending the Town of Fabius code by creating a new Section Article 7, Section 150 27A entitled Tier 3 Solar Energy Systems Overlay District is amended as follows;

- 1) Section B, Zoning Board of Appeals is substituted for Planning Board.
- 2) Section C. 1), Zoning Board of Appeals is substituted for Planning Board.
- D. Local Law No. 2, 2022 Town of Fabius, Solar Energy System Law, Article 7, Section 150 27 B is amended as follows:
- 1) Section 3, definitions, Solar Energy System, B & C, Zoning Board of Appeals is substituted for Planning Board.
- 2) Section 7, Zoning Board of Appeals is substituted for Planning Board.
- 3) Section 9, Zoning Board of Appeals is substituted for Planning Board.
- 5. The invalidity or unenforceability of any section, subsection, paragraph, sentence, clause, provision or phrase of the aforementioned sections, as declared by the valid judgment of any court of competent jurisdiction to be unconstitutional and or invalid, shall not affect the validity or enforceability of any other section, subsection, paragraph, sentence, clause, provision or phrase, which shall remain in full force and effect.
- 6. Any and all other sections of the Fabius Town Code, Ordinances, Rules or Regulations or parts thereof that may be in conflict with or are in conflict with this Local Law are hereby amended and supplemented to conform with intent and terms of this Law which shall control.
- 7. This law shall be effective upon filing with the office of the Secretary of State.
