Repeal of Local Law Number 2 of the Town of Fabius, 2019

A. Purpose and Intent. The purpose and intent of this Law is to allow the Town of Fabius to enter into possible contracts for payments in lieu of taxes as allowed by New York Real Property Tax Law Section 487, and to reinstate any and all exemptions from taxation for certain energy systems as allowed by Real Property Tax Law Section 487.

Now, Therefore:

a. Local Law Number 2 of 2019, of the Town of Fabius is hereby repealed in its entirety.

B. This law shall become effective on filing with the Secretary of State. This law will also be filed with the appropriate State Agency is required by Real Property Tax Law, Section 487.


