## BOROUGH OF FAIRVIEW ORDINANCE 23-15

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 7 "TRAFFIC" OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF FAIRVIEW

BE IT ORDAINED by the Mayor and Council of the Borough of Fairview, County of Bergen and State of New Jersey that those portions of the aforesaid set forth below are hereby amended as follows and that said amendments are to be effective immediately upon the passage of this Ordinance and that those sections not set forth below shall remain unchanged.

### § 7-14 PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN DAYS ON CERTAIN STREETS.

No person shall park or stand a vehicle between the hours on days specified upon any of the streets described, except where other parking regulations have been provided for. Fine: \$30; Cost: \$2 AF; \$0.98 SR; \$1 AV; \$0.50 EM; \$0.02 SM; \$1 BI; \$1. BA; \$2. DN; \$3. AM.

Monday, Tuesday, Wednesday, Thursday, Friday Name of Street Sides Hours Location

Day Avenue South 7:00 a.m. to 5:00 p.m. From Anderson Avenue to Shaler Avenue

Section 3. Severability. If any section, paragraph, clause, or provision of this ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, clause or provision so adjudged and the remainder of the ordinance shall be deemed valid and effective.

Section 4. Repeal of Prior Ordinances. All ordinances or parts of ordinances inconsistent with or in conflict with this ordinance are hereby repealed to the extent of such inconsistency.

Section 5. Effective Date. This ordinance shall take effect after final passage and publication as provided by law.
