ORDINANCE NO. 4760

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF FESTUS, MISSOURI, ENACTING SECTION 510.105 OF THE CODE OF ORDINANCES OF THE CITY OF FESTUS, MISSOURI, REGARDING HOURS OF OCCUPATION FOR CITY-OWNED PROPERTY; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, § 77.260, RSMo provides that the City Council of the City of Festus may enact and ordain any and all ordinances not repugnant to the constitution and laws of this state, and such as they shall be deemed expedient for the good government of the City, the preservation of peace and good order, the benefit of trade and commerce, and the health of the inhabitants thereof; and

WHEREAS, City staff recommends that the City adopt an ordinance amending the Code of Ordinances of the City of Festus, Missouri (the "Code") to restrict the use and occupation of property owned, leased, and/or maintained by the City between the hours of 11:00 P.M. and 5:00 A.M.; and

WHEREAS, the City Council of the City of Festus finds and determines that enacting a new Section 510.105 would be in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FESTUS, MISSOURI, AS FOLLOWS:

SECTION I. Chapter 510 of the Code of Ordinances of the City of Festus, Missouri, is hereby amended, by adding a new section, to be designated as Section 510.105, to read as follows:

TITLE V. BUILDING AND CONSTRUCTION.

CHAPTER 510. STREETS, SIDEWALKS, AND OTHER PUBLIC PLACES.

ARTICLE I. IN GENERAL.

SECTION 510.105. HOURS OF OPERATION.

A. Unless otherwise provided in this Code, no person shall be present upon property owned, leased and/or maintained by the City, between the hours of 11:00 P.M. and 5:00 A.M. Notwithstanding the foregoing, law enforcement and/or individuals engaging in necessary public business, including persons involved in emergency situations or incidents, or to contact law enforcement, shall be allowed to utilize or otherwise occupy property owned, leased and/or maintained by the City whenever necessary in the course of his/her duties.

- B. Nothing herein shall be construed to prohibit a person from being upon a public street or sidewalk during the hours identified in subsection (A) of this Section, so long as his or her conduct does not violate Section 210.720 of this Code.
- C. Any person violating this Section shall be subject to punishment in accordance with the provisions of Section 100.120 of this Code. Any person stopped for an alleged violation of this Section shall be given an opportunity to relocate prior to issuance of a violation notice or an arrest. Should it be determined that the individual found on, in, or otherwise occupying City grounds or any property owned, leased and/or maintained by the City during prohibited hours is houseless, said individual shall be provided a list maintained by the Missouri Department of Health and Senior Services regarding Crisis Shelters and Homeless Services.

SECTION II. All Ordinances or parts of Ordinances in conflict with this Ordinance are hereby repealed.

SECTION III. This Ordinance shall be in full force and effect upon its passage by the City Council and the approval by the Mayor.
