TOWN OF FISHKILL LOCAL LAW NO. 2 OF THE YEAR 2023

A local law amending the Town Code of the Town of Fishkill to add a new Article VI, entitled "Volunteer Firefighters and Volunteer Ambulance Workers Exemption," to Chapter 138, entitled "Taxation", to provide for an exemption to real property taxes for volunteer firefighters and volunteer ambulance workers.

SECTION 1. PURPOSE

The purpose of this Local Law is to promote the public health, safety and welfare by amending Chapter 138 of the Town Code, entitled "Taxation", to provide an exemption to real property taxes for volunteer firefighters and volunteer ambulance workers.

SECTION 2. MUNICIPAL HOME RULE LAW:

This law is adopted pursuant to the provisions of the Municipal Home Rule Law § 10(1)(ii)(a)(1) which grants local governments the authority to enact local laws regarding the public health, safety and welfare. To the extent the provisions of this Local Law are in conflict with State law, the Town Board hereby asserts its intention to supersede same pursuant to the Municipal Home Rule.

SECTION 3. AMENDMENT OF TOWN CODE:

A new Article VI entitled "Volunteer Firefighters and Volunteer Ambulance Workers Exemption" is added to the Town Code of the Town of Fishkill Chapter 138 entitled "Taxation", which shall provide as follows:

"Article VI. Volunteer Firefighters and Volunteer Ambulance Workers Exemption

§ 138-9 Purpose.

The purpose of this article is to enact a real property tax exemption for volunteer firefighters and volunteer ambulance workers pursuant to § 466-A of the Real Property Tax Law of the State of New York.

§ 138-10 Statutory authority.

This article is adopted pursuant to §466-A of the Real Property Tax Law of the State of New York to provide a real property tax exemption to enrolled members of an incorporated volunteer fire company, volunteer fire department, or incorporated volunteer ambulance corps to the extent of up to ten percent of the assessed value of such property for Town purposes, exclusive of special assessments.

§ 138-11 Exemption.

- A. A real property tax exemption of ten percent of assessed value for Town purposes, exclusive of special assessments, is hereby made available to enrolled members of an incorporated volunteer fire company, volunteer fire department, or incorporated volunteer ambulance corps serving the Town of Fishkill who meet the following qualifications:
 - 1. The applicant resides in the Town of Fishkill;
 - 2. The property is the primary residence of the applicant;
 - 3. The property is used exclusively for residential purposes; provided however, that in the event any portion of such property is not used exclusively for the applicant's residence but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this Section; and
 - 4. The applicant has been an enrolled member of such incorporated volunteer fire company, volunteer fire department, or volunteer ambulance corps, in good standing for at least two (2) years prior to submitting an application for tax exemption and has obtained a certificate from such organization certifying such membership.
- B. Any enrolled member of an incorporated volunteer fire company, volunteer fire department or incorporated voluntary ambulance corps who accrues more than twenty (20) years of active service, shall be entitled to claim the said ten percent exemption as authorized by §466-A of the New York State Real Property Tax Law for the remainder of his or her life as long as his or her primary residence is located within the Town of Fishkill and the property meets the requirements of this Article.
- C. Un-remarried spouses of volunteer firefighters or volunteer ambulance workers killed in the line of duty are entitled to continue to claim the exemption, provided, however, that:
 - 1. Such deceased volunteer had been an enrolled member for at least two years; and
 - 2. Such deceased volunteer had been receiving the exemption prior to his or her death; and
 - 3. Such un-remarried spouse is certified by an incorporated volunteer fire company, volunteer fire department, or incorporated volunteer ambulance corps as an un-remarried spouse of enrolled member who was killed in the line of duty.

- D. Un-remarried spouses of deceased volunteer firefighters or volunteer ambulance workers who were not killed in the line of duty may continue to claim the exemption; provided, however, that:
 - 1. Such deceased volunteer had been an enrolled member for at least twenty years; and
 - 2. Such deceased volunteer had been receiving the exemption for such property prior to the death of such volunteer; and
 - 3. Such un-remarried spouse is certified as an un-remarried spouse of a deceased member of such incorporated volunteer fire company, volunteer fire department or incorporated volunteer ambulance corps who had been enrolled and in good standing for at least twenty years.
- E. The application for such exemption must be filed annually with the Tax Assessor on or before the taxable status date with proof of entitlement to the exemption.

SECTION 4. SEVERABILITY

If any clause, sentence, paragraph, word, section or part of this local law shall be judged by any court of competent jurisdiction to be unconstitutional, illegal or invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, word, section or part thereof directly involved in the controversy in which judgment shall have been rendered.

SECTION 5. EFFECTIVE DATE

This local law will take effect immediately upon filing in the Office of the Secretary of State in Albany.
