**Local Law No. 2 of the year 2024**

**A local law amending § 81-8 of the Code of the Incorporated Village of Floral Park.**

## **Section 1. Legislative Intent**

This local law adds a subdivision "B" to section 81-8 of the Code to regulate the chaining of bicycles and other similar equipment on public property within the Village.

## **Section 2. Section 81-8 As Amended**

### Article II Use of Sidewalks

#### **§ 81-8. Bicycles, tricycles, motorcycles and other motorized devices**

A. It shall be unlawful for any person, except children under the age of 10 years old, to ride a tricycle or bicycle upon a path, sidewalk, lane or crosswalk in the Village or for any reason to ride a motorcycle or any other vehicle upon any path, sidewalk, lane or crosswalk in the Village.

B. No bicycle, motorcycle, moped, motorbike, motor scooter or any other type of motorized device shall be chained or otherwise affixed to public property, including to any fence, sign, parking meter, telephone pole or tree, within the Village. In the event a bicycle is so



chained or otherwise affixed to public property, in addition to penalties provided in Section 81-13 of this Code, the bicycle shall be removed and a notice shall be affixed to the location advising the owner that the bicycle is in the custody of the Floral Park Police Department.

**Section 3. Severability**

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

**Section 4. Effective Date**

This local law shall take effect immediately upon filing with the Secretary of State.




