ORDINANCE #24-01**

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK, IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING SECTION 238-24 OF CHAPTER 238 “VEHICLES AND TRAFFIC” OF THE CODE OF ORDINANCES OF THE BOROUGH OF FLORHAM PARK**

**WHEREAS**, Ordinance #3-02 was adopted by the Borough Council of the Borough of Florham Park and codified in the Borough Code in Chapter 238, entitled “Vehicles and Traffic”; and

**WHEREAS**, Section §238-24 established the intersections within the Borough that are designated as stop intersections; and

**WHEREAS**, the Borough Engineering department has determined that one stop intersection needs to be added to §238-24 as a new stop sign will be installed at Hopping Lane; and

**WHEREAS**, Section §238-24 needs to be further amended to correct a clerical error.

**IT IS HEREBY ORDAINED** by the Borough Council of the Borough of Florham Park, Morris County, State of New Jersey, as follows:

**SECTION 1.** Chapter 238, Vehicles and Traffic, Section 24, Stop intersections, is hereby amended to add the following stop intersection and make one correction:

<b>Intersection</b>	<b>Stop Sign(s) on</b>
Circle Road and <del>Afton</del> <u>Afton</u> Drive	Afton Drive
<u>Hopping Lane and Gregory Drive</u>	<u>Hopping Lane</u>

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

**SECTION 3.** If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase, or sentence shall be deemed separable.

**SECTION 4.** This Ordinance shall take effect upon final publication as provided by law.
