ORDINANCE #24-17**

**AN ORDINANCE OF THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF FLORHAM PARK IN THE COUNTY OF MORRIS, STATE OF NEW JERSEY, AMENDING SECTION 16, “DEPARTMENT OF PUBLIC WORKS”, SUBSECTION A(2) OF CHAPTER 2 “ADMINISTRATION OF GOVERNMENT” OF THE CODE OF ORDINANCES OF THE BOROUGH OF FLORHAM PARK TO ESTABLISH A FIELD MAINTENANCE SECTION WITHIN THE DEPARTMENT**

**WHEREAS**, Ordinance #17-99 was adopted by the Borough Council of the Borough of Florham Park and codified in the Borough Code of Ordinances in Chapter 2, entitled “Administration of Government”; and

**WHEREAS**, Section §2-16 “Department of Public Works”, Subsection A(2) establishes the three (3) sections of the Department of Public Works in the Borough of Florham Park; and

**WHEREAS**, the Department of Public Works wishes to organize the Department into four (4) sections, with the addition of a Field Maintenance section.

**IT IS HEREBY ORDAINED** by the Borough Council of the Borough of Florham Park, Morris County, State of New Jersey, as follows:

**SECTION 1.** Chapter 2, Administration of Government, Section 16, Department of Public Works, Subsection A(2), is hereby amended as follows:

A. Functions

(2) The Department of Public Works shall be organized into ~~three~~ four sections which include Roads, Buildings and Grounds, ~~and~~ Vehicle Maintenance, and Field Maintenance, with workers assigned to each section as needed to accomplish Department goals and objectives. The supervisors within the sections shall be superintendents, supervisors and foremen, who shall report to the Director.

**SECTION 2.** All ordinances or parts of ordinances inconsistent herewith are hereby repealed as to such inconsistencies.


**SECTION 3.** If any article, section, subsection, paragraph, phrase, or sentence is for any reason held to be unconstitutional or invalid, said article, section, subsection, paragraph, phrase, or sentence shall be deemed separable.

**SECTION 4.** This Ordinance shall take effect upon final publication as provided by law.


