The City Council of the City of Fond du Lac do ordain as follows:

**Section 1.** That Section 630-39, No Parking Zones, Schedule E, is hereby amended as follows:

**Add Thereto:**

<i>Name of Street</i>	<i>Sides</i>	<i>Location</i>
E. Merrill Avenue	South	From the east back of walk on N. Park Avenue east 85 feet.

**Section 2.** Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.


**Section 3.** The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

**Section 1.** That Section 630-39, No Parking Zones, Schedule E, is hereby amended as follows:

**Add Thereto:**

E. Merrill Avenue	South	From the east back of walk on N. Park Avenue east 85 feet.
N. Park Avenue	East	From the south back of walk on E. Merrill Avenue south 45 feet

**Section 2.** Any person violating the provisions of this Ordinance shall be subject to the penalty provided in Section 1-4 of the Code.

**Section 3.** The appropriate City officials are hereby authorized and directed to take such action as is necessary to effectuate the terms of this Ordinance.

**Section 4.** All other ordinances and resolutions inconsistent with the provisions of this Ordinance are hereby repealed.

**Section 5.** This Ordinance shall take effect and be in force upon its passage and publication as provided by law.

**Re:** **Request to add parking restrictions along E Merrill Avenue and N Park Avenue**

This memo and Exhibit "C" covers agenda item listed as "C" for the Advisory Parking & Traffic Board's July 18, 2024 meeting:

Request to add parking restriction "No Parking Zones", in accordance with Code of Ordinances Section 630-39, Schedule E.

Location: Merrill Avenue, East, North Side from the east back of walk on N. Park Avenue east 85 feet.

Request to add parking restriction "No Parking Zones", in accordance with Code of Ordinances Section 630-39, Schedule E.

Location: Park Avenue, North, East Side from the south back of walk on E. Merrill Avenue south 45 feet.

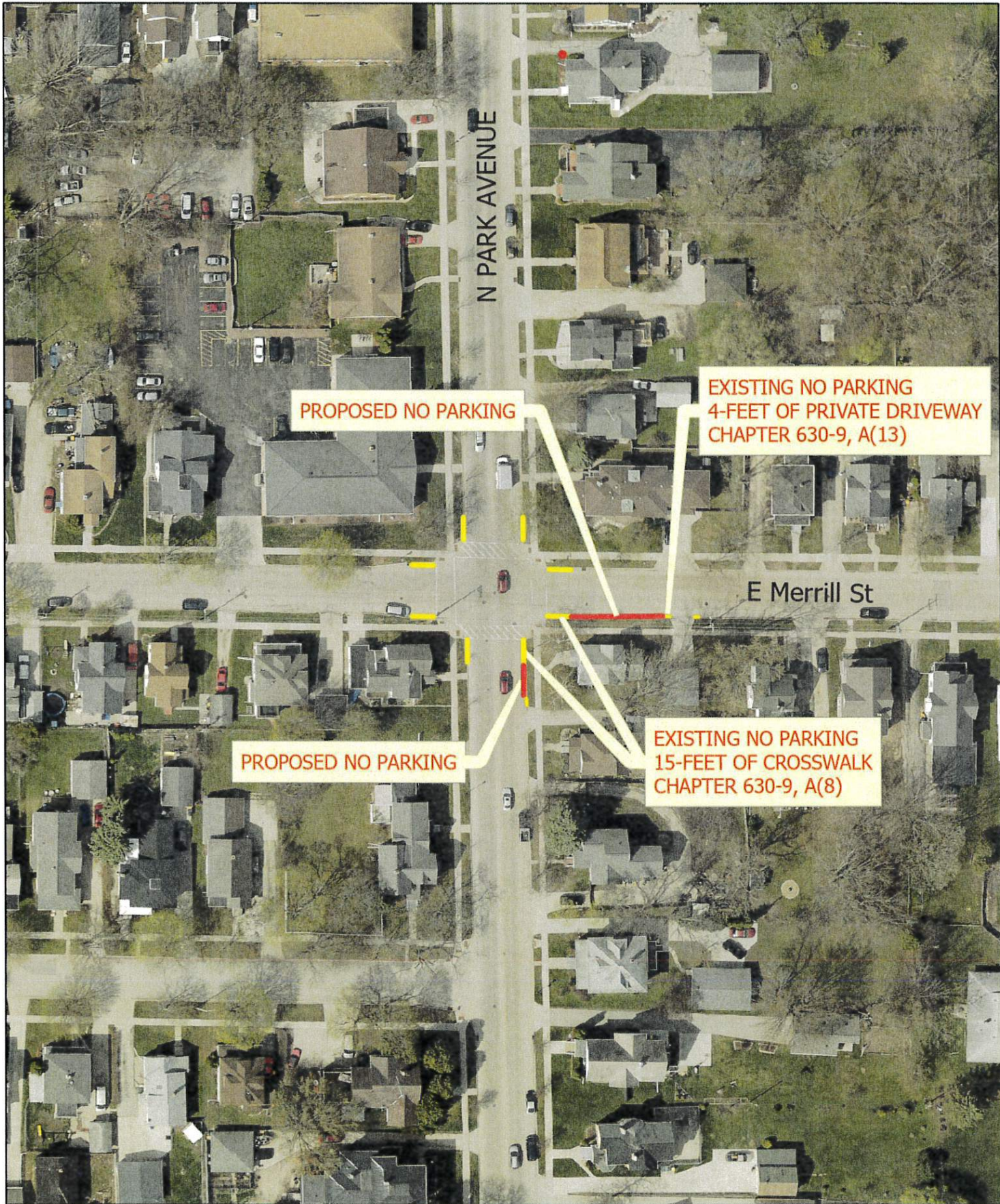
Mr. Justin Graef, owner of the property located at 69 N. Park Avenue, initiated this request. Mr. Graef is requesting the change on E. Merrill Avenue because he no longer feels safe pulling out of his driveway and has indicated that he was almost hit several times last month. Mr. Graef is requesting the change on N. Park Avenue to allow traffic to be able to go around someone that is turning onto E. Merrill Avenue.

Two WI State parking restrictions along with City of Fond du Lac restrictions already apply along E. Merrill Avenue and N. Park Avenue.

- **WI State Statute 346.53(4) and City of Fond du Lac Chapter 630-9 A(13)** states that parking is prohibited within four feet of the entrance to an alley or a private road or driveway.
- **WI State Statute 346.53(5) and City of Fond du Lac Chapter 630-9 A(8)** states that parking is prohibited within 15 feet of the near limits of a crosswalk.

It is not standard practice to allow "spot" restriction in front of select houses. If the City were to begin granting these types of restrictions, this would lead to more requests of this type eventually complicating the overall parking restrictions in the City with a patchwork of zones.

The Engineering and Traffic Division does not support the addition of parking restrictions on E. Merrill Avenue or N. Park Avenue.

The City Engineer recommended denying this request for no parking on Merrill Ave and Park Ave as requested by a neighboring property owner. The Advisory Parking and Traffic Board partially agreed with this recommendation and voted to recommend denial of no parking on Park Ave, but recommended approval of no parking on Merrill Ave.

If a Council member wants to follow the City Engineer's recommendation, the appropriate motion is to deny Ordinance 3796A. If a City Council member wants to follow the recommendation of the Advisory Parking and Traffic Board, the appropriate motion would be to approve Ordinance 3796B. If a City Council member wants to overrule the recommendations and have no parking on both Merrill and Park, the appropriate motion would be to approve Ordinance 3796A.
