ORDINANCE NO. 1111**

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AMENDING CHAPTER 15, OF THE FOREST HILLS BOROUGH CODE OF ORDINANCES, MOTOR VEHICLES AND TRAFFIC, AS AMENDED, BY AMENDING SECTION 15-403 TO REMOVE THE PARKING RESTRICTION FROM GREENSBURG PIKE.

WHEREAS, Section 1202(12) of the Borough Code, 8 Pa.C.S. § 1202(12), authorizes the Borough of Forest Hills (the "Borough") to regulate parking of vehicles within the Borough; and

WHEREAS, Chapter 61 of the Pennsylvania Motor Vehicle Code, 75 Pa.C.S. § 6101 *et seq.* ("Vehicle Code") authorizes the Borough to exercise, by ordinance, certain powers pertaining to the operation of motor vehicles on highways within its boundaries, including the power to make certain regulations regulating or prohibiting stopping, standing or parking; and

WHEREAS, Chapter 15 of the Forest Hills Borough Code of Ordinances, Motor Vehicles and Traffic, as amended, regulates vehicles, traffic, and parking within the Borough; and

WHEREAS, the Council of the Borough desires to amend § 15-403 of Chapter 15 of the Forest Hills Borough Code of Ordinances, Parking Prohibited in Certain Locations Certain Days and Hours, to remove the parking limitation in place for certain portions of Greensburg Pike.

NOW, THEREFORE, the Council of the Borough of Forest Hills hereby ordains and enacts as follows:

SECTION 1. Section 15-403 of Chapter 15 of the Forest Hills Borough Code of Ordinances, Motor Vehicles and Traffic, is amended by deleting the stricken text as follows:

§15-403 Parking Prohibited in Certain Locations Certain Days and Hours.

Parking shall be prohibited in the following locations at all times on the days and between the hours indicated in this section as follows:

Street	Side	Between	Restricted Hours

SECTION 2. The appropriate Borough officials and/or designees are hereby authorized to remove the necessary signage and curb striping to effectuate the changes in Section 1 hereof.

SECTION 3. All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.

SECTION 4. This Ordinance shall take effect in accordance with applicable law.
