

**BOROUGH OF FRANKLIN LAKES  
ORDINANCE NO. 1917**

**AN ORDINANCE AUTHORIZING AND PROVIDING FOR CERTAIN  
CAPITAL PROJECTS AND PURCHASES AND APPROPRIATING  
\$454,000.00 FOR SAID PROJECTS AND PURCHASES AUTHORIZED TO  
BE UNDERTAKEN IN, BY AND FOR THE BOROUGH OF  
FRANKLIN LAKES, IN THE COUNTY OF BERGEN, NEW JERSEY**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF  
FRANKLIN LAKES, IN THE COUNTY OF BERGEN, NEW JERSEY, AS FOLLOWS:**

**Section 1.** (a) Pursuant to the applicable statutes of the State of New Jersey, the purposes described in Section 2 of this ordinance, together with other purposes appurtenant or incidental thereto or therefor, are hereby authorized to be made or acquired by the Borough of Franklin Lakes, in the County of Bergen, State of New Jersey (the "Borough").

(b) It is hereby determined and declared by this Borough Council of the Borough that the estimated aggregate maximum amount of money to be raised from all sources for the purposes stated in Section 2 is \$454,000.00. In order to finance the cost of the purposes stated in Section 2, there is hereby appropriated to said purposes the sum of \$454,000.00, and said sum is hereby appropriated from the sources described in Section 2 for said purposes.

**Section 2.** The purposes hereby authorized, the estimated costs thereof, and the sources of appropriation therefor, are as follows:

Purchase of DPW Backhoe; Purchase and Installation of Oil/Water Separator; Purchase of Fire Department SCBA Equipment; and Purchase and Installation of Diesel Exhaust Systems for Fire Houses	\$454,000.00	Reserve from Sale of Assets

**Section 3.** The following additional matters are hereby determined, declared, recited and stated:

The purposes described in Section 2 of this ordinance are not current expenses and purchases which the Borough may lawfully make as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

**Section 4.** Any grant or other moneys received for the purposes described in Section 2 hereof shall be applied to the payment of the costs thereof. Any grant or other moneys received shall be reimbursed back to the original source of appropriation.

**Section 5.** The capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board of the State of New Jersey, Department of Community Affairs, showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Borough Clerk and is available there for public inspection.

**Section 6.** To the extent that any previous ordinance or resolution is inconsistent with this ordinance or contradictory hereto, said previous ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

**Section 7.** The provisions of this ordinance are severable. To the extent any clause, phrase, sentence, paragraph or provision of this ordinance shall be declared invalid, illegal, or unconstitutional, the remaining provisions shall continue in full force and effect.

**Section 8.** This ordinance shall take effect at the time and in the manner provided at law.
