The following directive is an excerpt of the Minutes of the Board of Trustees Meeting of October 17, 2011:

It was moved by Trustee Pineyro, seconded by Trustee Martinez, and carried to adopt the following resolution:

**BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF FREEPORT, NEW YORK,** that the **VEHICLE AND TRAFFIC REGULATIONS Sec. 56.** Fire Department parking, areas designated be amended as follows:

**Sec. 56. Fire Department parking, areas designated.**

It shall be unlawful for any person to park an automobile or other vehicle or to permit an automobile or other vehicle to remain in or upon the following public streets or public parking fields unless the operator of such vehicle is a member of the Freeport Volunteer Fire Department responding to the firehouse immediately adjacent thereto:

**DELETE:**

(d) Parking Field No. 4, west side of the Broadway exit, beginning at a point 70 feet north of the northerly curblineline of Broadway north for a distance of 143 feet.

**ADD:**

(d) Parking Field No. 4, west side of the Broadway exit, beginning at a point 40 feet north of the northerly curblineline of Broadway north for a distance of 143 feet.

(e) Parking Field No. 4, east side of the Broadway exit, beginning at a point 20 feet north of the northerly curblineline of Broadway north for a distance of 120 feet.
