A LOCAL LAW TO AMEND CHAPTER 58 OF THE CODE OF THE VILLAGE OF FREEPORT, ENTITLED "SALARIES AND COMPENSATION" BY ADDING ARTICLE I COMMUNITY DEVELOPMENT AGENCY §58-1 ENTITLED "COMPENSATION OF MEMBERS".

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF FREEPORT AS FOLLOWS:

Section 1. Chapter 58, Article I Community Development Agency, §58-1, entitled "Compensation of members." which reads as follows, is hereby adopted:

Article I Community Development Agency §58-1 Compensation of members.

The annual compensation of the members of each of the separate boards and commissions of the Incorporated Village of Freeport shall be as set forth in the adopted budget for the Incorporated Village of Freeport, New York.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State's Office.
