### A LOCAL LAW TO AMEND CHAPTER 86 OF THE CODE OF THE VILLAGE OF FREEPORT, ENTITLED "BUILDING CONSTRUCTION" BY ADDING §86-9E.

# BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE INCORPORATED VILLAGE OF FREEPORT AS FOLLOWS:

Section 1. Chapter 86, §86-9E, which reads as follows, is hereby adopted:

#### Article II Administrative Provisions

§86-9E If an applicant wishes to have his/her permit application reviewed in an expedited timeframe, applicant may apply for expedited permit application/plan review. The Board of Trustees by resolution shall adopt and from time to time may amend a schedule of fees payable by an applicant for expedited building permit/plan review.

Section 2. This local law shall take effect immediately upon filing with the Secretary of State's Office.
