

**TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET
ORDINANCE NO. 4426-24**

AN ORDINANCE AMENDING THE CODE OF THE TOWNSHIP OF FRANKLIN, COUNTY OF SOMERSET, STATE OF NEW JERSEY, MORE PARTICULARLY CHAPTER 226, VEHICLES AND TRAFFIC, PROVIDING A NEW SECTION 226-35, ROAD CLOSURES EXCEPT FOR EMERGENCY VEHICLES (PROVIDING FOR THE CLOSURE OF A PORTION OF BROOKLINE AVENUE TO ALL TRAFFIC EXCEPT EMERGENCY VEHICLES)

SUMMARY

An Ordinance amending Chapter 226, Vehicles and Traffic, with the addition of a new section, Section 226-35, Road Closure Except for Emergency Vehicles, with the provision for the closure of a portion of Brookline Avenue (f/k/a First Street).

NOW, THEREFORE BE IT ORDAINED by the Township Council of the Township of Franklin, Somerset County, that the Code of the Township of Franklin, Chapter 226, Vehicles and Traffic, is hereby amended and supplemented as follows:

SECTION I

Section 226-35, Road Closure Except for Emergency Vehicles, is added to Chapter 226, Vehicles and Traffic, in the Municipal Code of the Township of Franklin as follows:

§226-35. Road closure except for emergency vehicles.

BROOKLINE AVENUE (F/K/A FIRST STREET)

1. 50 feet wide road beginning 75 feet southeast of its intersection with Drake Street and extending southeasterly, along its various courses, a distance of approximately 200 feet to its terminus at Mile Run Brook.
2. Notice of the closing shall be posted at the points of the closed section of the roadway and a barricade erected at those points.
3. In accordance with the provisions of N.J.S.A. 39:4-94.2, no person shall drive a vehicle over the closed portion of the roadway.

SECTION II

Each clause, section or subsection of this ordinance shall be deemed a separate provision to the intent that if any such clause, section or subsection should be declared invalid, the remainder of the ordinance shall not be affected.

SECTION III

All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed as the extent of such inconsistency.

SECTION IV

This ordinance shall take effect immediately upon adoption and publication according to law.
