**CAPITAL ORDINANCE APPROPRIATING \$120,000.00 FROM  
TOWNSHIP OF FREDON GENERAL CAPITAL FUND CAPITAL

**BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE  
TOWNSHIP OF FREDON, IN THE COUNTY OF SUSSEX, NEW  
JERSEY, AS FOLLOWS:**

Section 1. \$120,000.00 from the Township of Fredon General Capital Fund Capital Improvement Fund for milling and paving the following road: Glenn Terrace, is hereby appropriated.

Section 2. This ordinance shall take effect immediately after final adoption.
