
BE IT ORDAINED by the Board of Health Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter BH6. Campgrounds. § BH6-3. APPLICATION; FEE; be and is hereby amended as follows:

Any person, firm or corporation who shall operate a “private campground” shall make application to the Clerk by filing a written request to do so with the Clerk at least 15 days prior to the commencement of business and shall pay a license fee of \$125.00 per year, or any part thereof. All licenses shall expire on the last day of the calendar year in which granted.

One inspection shall be made prior to the commencement of the “public campground” and no business shall be conducted or occupancy permitted on the campgrounds until the Sanitary Inspector shall have completed his inspection and endorsed on the license his approval and the date thereof.
