
AN ORDINANCE AMENDING THE BOARD OF HEALTH ORDINANCES OF THE TOWNSHIP OF FRANKFORD IN THE COUNTY OF SUSSEX TO AMEND BOARD OF HEALTH CHAPTER BH7. RETAIL FOOD ESTABLISHMENTS; § BH7-5 FOOD HANDLER'S CERTIFICATION FEES.

BE IT ORDAINED by the Board of Health Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter BH7. RETAIL FOOD ESTABLISHMENTS; § BH7-5 FOOD HANDLER'S CERTIFICATION FEES; be and is hereby amended as follows:

County follows Chapter 24 on food safety certification requested for certain personnel/establishment types, and no longer offers food handling certification courses as they are available through accredited food safety certification programs.
