AN ORDINANCE AMENDING THE BOARD OF HEALTH ORDINANCES OF THE TOWNSHIP OF FRANKFORD IN THE COUNTY OF SUSSEX TO AMEND BOARD OF HEALTH CHAPTER BH2. SEWAGE DISPOSAL SYSTEMS, § BH2-6. CERTIFICATE OF COMPLIANCE WITH BOARD OF HEALTH REQUIREMENTS.

BE IT ORDAINED by the Board of Health Committee of the Township of Frankford, in the County of Sussex, and State of New Jersey that Chapter BH2. Sewage Disposal Systems, § BH2-6. Certificate of Compliance with Board of Health Requirements be and is hereby amended as follows:

- a. New individual disposal systems shall not be placed in operation, nor shall new dwellings or buildings or additions thereto be sold or occupied which must rely on such a system for sewage disposal until the Board of Health shall have issued a certificate indicating that the disposal system has been located and constructed in compliance with the terms of the permit issued and the requirements of the standards in this chapter. Issuance of such certificate shall not be required for alterations to an existing individual sewage disposal system.
- b. An engineer shall certify that they have inspected and approved the completed installation, by signed and sealed drawings, prior to issuance of the certification of compliance.

This section shall not be construed to exempt any individual disposal system from the necessity of a certificate of compliance which may be required under N.J.A.C. 7:9(a)-1 et seq.
