## **Article XII Special Use Permits**

### § 640-74 Application contents and fee.

A request for a special use permit shall be submitted on an application form available at the City Code Enforcement Office. Each application shall be accompanied by a site plan, floor plan, and a fee established by resolution of the Common Council as set forth in Chapter A700 of this Code to help defray the cost of handling the application, no part of which is refundable. Applications shall be submitted to the Code Enforcement Officer, who shall then transmit them to the Council.
