§ C263A West Broadway Parking Improvement District. [Added 12-28-1993 by L.L. No. 4-1993]

1. There shall be an improvement district known as "West Broadway Parking Improvement District" bounded as follows and to include the following properties:

All property with frontage on the south side of West Broadway and the north side of West Broadway situate between West First Street and West Second Street; all property with frontage on the west side of West First Street between West Broadway and Beech Street; all property with frontage on Beech Street between West First Street and West Second Street; and all property with frontage on West Second Street between West Broadway and Beech Street.

2. A special assessment in the sum of \$8,000 annually, effective January 1, 2025, is hereby levied against the West Broadway Parking Improvement District, the proceeds of which are to be applied to defray the expense to the City of Fulton for the acquisition, improvement, maintenance and improvement of said district.
