

**ORDINANCE #2122-2023**

**AN ORDINANCE REPEALING AND REVISING PORTIONS OF SECTION 319-35  
BUS STOPS.**

**WHEREAS**, it is appropriate for the Township of Galloway to update and revise certain portions of Section 319-35 pertaining to Bus Stops;

**NOW, THEREFORE, BE IT ORDAINED** by the Municipal Council for the Township of Galloway, County of Atlantic and State of New Jersey that Chapter 319-35 Bus Stops be amended and revised as follows:

**§ 319-35 Bus stops.**

The locations described are hereby designated as bus stops. No other vehicle other than an omnibus, picking up or discharging passengers, shall be permitted to occupy said location between the hours indicated.

Jimmie Leeds Road (CR 561) westbound on the northerly side thereof at:

Seaview Avenue, near side: beginning at the easterly curblineline of Seaview Avenue and extending 105 feet easterly therefrom.

Ash Avenue- Mid Block (475 feet west): beginning 475 feet west of the westerly curb line of Ash Avenue and extending 135 feet westerly therefrom.

Ash Avenue- Mid Block (675 feet east): beginning 675 feet east of the easterly curb line of Ash Avenue and extending 135 feet easterly therefrom.

**C.**

Pitney Road (CR 634) northbound on the easterly side thereof at:

Jimmie Leeds Road, mid-block (200 feet north): beginning 200 feet north of the northerly curbline of Jimmie Leeds Road and extending 105 feet northerly therefrom.

Spencer Lane, far side: beginning at the northerly curbline of Spencer Lane and extending 100 feet northerly therefrom.

**D.**

Pitney Road (CR 634) southbound on the westerly side thereof at:

**(1)**

Spencer lane, near side: beginning at the northerly curblineline of Spencer Lane and extending 105 feet northerly therefrom.

**E.**

Collins Road westbound on the northerly side thereof at:

**(1)**

Greenwich Drive East, near side: beginning at the easterly curblineline of Greenwich Drive East and extending 105 feet easterly therefrom.

**(2)**

Cherokee Drive West, far side: beginning at the westerly curblineline of Cherokee Drive West and extending 100 feet westerly therefrom.

**F.**

Collins Road eastbound on the southerly side thereof at:

**(1)**

Federal Court, far side: beginning at the easterly curblineline of Federal Court and extending 100 feet easterly therefrom.

**(2)**

Greenwich Drive East, far side: beginning at the easterly curblineline of Greenwich Drive East and extending 100 feet easterly therefrom.

**G.**

Wrangleboro Road northbound on the easterly side thereof at:

**(1)**

Great Creek Road, near side: beginning at the southerly curblineline of Great Creek Road and extending 105 feet southerly therefrom.

**(2)**

Walden Way, far side: beginning at the northerly curblineline of Walden Way and extending 100 feet northerly therefrom.

**(3)**

Collins Road, near side: beginning at the southerly curbline of Collins Road and extending 105 feet southerly therefrom.

**H.**

Wrangleboro Road southbound on the westerly side thereof at:

**(1)**

Collins Road, far side: beginning at the southerly curbline of Collins Road and extending 100 feet southerly therefrom.

**(2)**

Navasink Drive, near side: beginning at the northerly curbline of Navasink Drive and extending 150 feet northerly therefrom.

**(3)**

Reeds Road, near side: beginning at the northerly curbline of Reeds Road and extending 105 feet northerly therefrom.

**(4)**

Great Creek Road, far side: beginning at the southerly curbline of Great Creek Road and extending 105 feet southerly therefrom.

**BE IT FURTHER ORDAINED**, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

**BE IT FURTHER ORDAINED**, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

**BE IT FURTHER ORDAINED**, that this Ordinance shall take effect twenty (20) days after final passage and publication according to law, except as provided for in N.J.S.A. 40:69A-181 or N.J.S.A. 40:74-4.

**NOTICE IS HEREBY GIVEN** that the foregoing Ordinance was introduced in and passed the first reading at a meeting of the Township Council of the Township of Galloway, County of Atlantic and State of New Jersey, held on November 14th, 2023, and said Ordinance will be further considered for final passage and adoption at a public hearing to be held at the Municipal Complex located at 300 East Jimmie Leeds Road, Galloway, New Jersey 08205, on December 12th, 2023 at 6:30 PM or as soon thereafter as the matter may be reached.
