ORDINANCE #2122-2023

AN ORDINANCE REPEALING AND REVISING PORTIONS OF SECTION 319-35 BUS STOPS.

WHEREAS, it is appropriate for the Township of Galloway to update and revise certain portions of Section 319-35 pertaining to Bus Stops;

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council for the Township of Galloway, County of Atlantic and State of New Jersey that Chapter 319-35 Bus Stops be amended and revised as follows:

§ 319-35 **Bus stops**.

The locations described are hereby designated as bus stops. No other vehicle other than an omnibus, picking up or discharging passengers, shall be permitted to occupy said location between the hours indicated.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section paragraph, subsection, clause or provision so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect twenty (20) days after final passage and publication according to law, except as provided for in N.J.S.A. 40:69A-181 or N.J.S.A. 40:74-4.

NOTICE IS HEREBY GIVEN that the foregoing Ordinance was introduced in and passed the first reading at a meeting of the Township Council of the Township of Galloway, County of Atlantic and State of New Jersey, held on November 14th, 2023, and said Ordinance will be further considered for final passage and adoption at a public hearing to be held at the Municipal Complex located at 300 East Jimmie Leeds Road, Galloway, New Jersey 08205, on December 12th, 2023 at 6:30 PM or as soon thereafter as the matter may be reached.
