ORDINANCE 2026-1036

AN ORDINANCE OF THE BOARD OF ALDERMEN OF THE CITY OF GARDEN CITY, MISSOURI, ACCEPTING THE PLAT OF SURVEY FOR PARCEL ID 19-01-01-100-002-002.000, GARDEN CITY, MISSOURI.

WHEREAS, on January 6, 2026, the Board of Alderman adopted Ordinance 2026-1017 approving the lot split of Parcel ID 19-01-01-100-002-002.000; and

WHEREAS, Dianna and Terry V. Allen, Jr., the property owners of Parcel 19-01-01-100-002-002.00, Garden City, Missouri, has requested that the property be combined into 2 (two) parcels; and

WHEREAS, a plat of survey for the lot split has been submitted and reviewed for approval.

NOW, THEREFORE BE IT ORDAINED, BY THE BOARD OF ALDERMEN OF THE CITY OF GARDEN CITY, MISSOURI AS FOLLOWS:

- Section 1. Acceptance of Plat**
That the plat of survey for Parcels 19-01-01-100-002-002.00, Garden City, Missouri is accepted.
- Section 2. Exhibit**
That a copy of the Plat of Survey, marked “Exhibit A,” is attached hereto and incorporated herein by reference.
- Section 3. Record**
That a copy of this ordinance shall be kept on file in the office of the City Clerk.
- Section 4. Repealer**
That all ordinances in conflict herewith are hereby repealed.
- Section 5. Scrivener’s Errors**
That the City Clerk is authorized by this ordinance to correct any scrivener’s errors identified within this Ordinance.
- Section 6. Effective Date.**
That this Ordinance shall be in full force and effect immediately upon its execution by the Board of Aldermen of the City of Garden City, Missouri.




